[Settlement of Lawsuit <u>and Supplemental Appropriation</u> - Raymond Kruse and Ashley Kruse - \$325,000]

Ordinance authorizing settlement of the lawsuit filed by Raymond Kruse and Ashley Kruse against the City and County of San Francisco for \$325,000; the lawsuit was filed on September 17, 2014, in San Francisco Superior Court, Case No. CGC-14-541704; entitled Raymond Kruse, et al. v. Precision Engineering, Inc., et al.; the lawsuit involves alleged property damage arising from flooding: and appropriating \$325,000 from the Water Enterprise fund balance for such purpose.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Raymond Kruse</u>, et al. v. <u>Precision Engineering</u>, Inc., et al., San Francisco Superior Court, Case No. CGC-14-541704 by the payment of \$325,000. The lawsuit involves alleged property damage arising from flooding.

Section 2. The above-named action was filed in San Francisco Superior Court on September 17, 2014, and the following parties were named in the lawsuit: Plaintiffs: Raymond Kruse and Ashley Kruse, Defendants: Precision Engineering, Inc. and the City and County of San Francisco.

Section 3. The Board herein appropriates \$325,000 from the Water Enterprise fund balance for use by the San Francisco Public Utilities Commission for purposes of settling the litigation.
