3 **Resolution supporting Fiscal Year 2008-2009 Community Development Block Grant**  
4 **(CDBG) Action Plan Goals.**

6 WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as  
7 amended, and related federal regulations, the City and County of San Francisco is eligible to  
8 apply for and receive Community Development Block Grant (CDBG) funding from the U.S.  
9 Department of Housing and Urban Development (HUD); and

10 WHEREAS, The City and County of San Francisco anticipates receiving approximately  
11 \$21,500,000 in CDBG Program Funds from HUD in 2008-09; and,

12 WHEREAS, on behalf of the City and County of San Francisco, the Mayor’s Office of  
13 Community Development (MOCD) is preparing to release a Request for Proposals (RFP) for  
14 the 2008-09 CDBG Program; and,

15 WHEREAS, the RFP is in concert with the MOCD Consolidated Plan for program years  
16 2005-2009; and,

17 WHEREAS, the Consolidated Plan was approved by HUD in 2005; and,

18 WHEREAS, the Consolidated Plan details the Mayor’s Office of Community  
19 Development and the Mayor’s Office of Housing seven goals for the CDBG Program: 1)  
20 Promote economic self-sufficiency for low and moderate income families; 2) Strengthen  
21 neighborhood vitality; 3) Increase the provision of timely, relevant and effective social  
22 services; 4) Promote equity-based public policy strategies; 5) Create housing opportunities for  
23 the homeless; 6) Create affordable rental housing for individuals and families with incomes up  
24 to 60% of San Francisco median income; and 7) Create homeownership opportunities for  
25 individuals and families up to 100% of San Francisco median income, and support existing

1 homeownership programs including funding housing counseling agencies to advise eligible  
 2 San Franciscans of existing homeownership programs, for families up to 120% of median  
 3 income; now, therefore, be it

4       RESOLVED, That the Board of Supervisors continues to support the seven 2005-2009  
 5 CDBG Consolidated Plan goals, and the related 2008-2009 Request for Proposals to achieve  
 6 these goals.
