Resolution retroactively authorizing the Department of Public Health to accept and expend a grant in the amount of \$373,084.11 from the San Francisco General Hospital Foundation for participation in a program, entitled "Children's Health Center's HealthySteps," for the period of November 1, 2023, through June 30, 2024.

WHEREAS, The San Francisco General Hospital Foundation (SFGHF) has agreed to fund the Department of Public Health (DPH) in the amount of \$373,084.11 for participation in a program, entitled "Children's Health Center's HealthySteps," for the period of November 1, 2023, through June 30, 2024; and

WHEREAS, The Children's Health Center's HealthySteps Program provides screening, prevention and early intervention services to approximately 3,000 San Francisco Health Network (SFHN) primary care patients ages 0-5 and their SFHN caregivers, including dyadic/family-centered behavioral health promotion and prevention services to address adverse childhood experiences (ACEs) and interrupt inter-generational trauma; and

WHEREAS, Targeted Tier 2 and 3 services are provided to 20% of the Chinatown Community Children (CHC) early childhood population that was not otherwise accessing care; and

WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and WHEREAS, A request for retroactive approval is being sought because DPH received the memorandum on October 20, 2023, for a project start date of November 1, 2023; and

WHEREAS, The Department proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and, be it

FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant in the amount of \$373,084.11 from the SFGHF; and, be it

FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City.
