

1 [Lease of Passenger Van to Delancey Street Foundation]
2 AUTHORIZING THE DIRECTOR OF THE MAYOR'S CRIMINAL JUSTICE COUNCIL TO
3 LEASE A CHEVROLET ASTRO PASSENGER VAN, V.I.N. 1GNM19W4XB129948, TO
4 THE DELANCEY STREET FOUNDATION, FOR A PERIOD OF SEVEN YEARS
5 (RENEWABLE THEREAFTER AT THE DISCRETION OF THE DIRECTOR, MAYOR'S
6 CRIMINAL JUSTICE COUNCIL) FOR THE HEREAFTER MENTIONED PURPOSES, FOR
7 THE AMOUNT OF ONE DOLLAR (\$1.00) PER ANNUM, PAYABLE IN FULL AT LEASE
8 INCEPTION, AND REQUIRING THE DELANCEY STREET FOUNDATION TO MAINTAIN
9 INSURANCE COVERAGES, INCLUDING THE CITY AND COUNTY AS NAMED INSURED,
10 WHICH SHALL BE APPROVED BY THE CITY AND COUNTY'S RISK MANAGER, AND
11 THE MAINTENANCE OF SUCH INSURANCE BEING AN EXPRESS CONDITION OF THIS
12 LEASE.

14 WHEREAS, The Delancey Street Foundation is the lead agency for
15 implementation of the Comprehensive Juvenile Justice Local Action
16 Plan (LAP) for the City and County of San Francisco; and,

17 WHEREAS, five of the six component programs comprising the
18 Circle of Care of the LAP, are Community Assessment and Referral
19 Center, Safe Haven, Safe Corridor, Life Learning Academy and Life
20 Learning Girls' Residential Treatment Center; and,

21 WHEREAS, daily transportation of program participants is an
22 integral part of the five programs herein enumerated; and,

23 WHEREAS, the City and County of San Francisco possesses a 1999
24 Chevrolet Astro van, V.I.N. 1GNM19W4XB129948, purchased with grant
25 funds of the Local Law Enforcement Block Grant program, for the

1 purpose of use of that passenger van in the transportation of program
2 participants of the LAP; and,

3 WHEREAS, the use of the van enables the Delancey Street
4 Foundation to perform an important public purpose for the benefit of
5 the citizens of San Francisco, that purpose being the full provision
6 of secure, supervised participant transportation required by five
7 programs of the Circle of Care of the LAP enumerated herein; now,
8 therefore, be it

9 RESOLVED, That the Board of supervisors authorizes the Director
10 of the Mayor's Criminal Justice Council to lease a Chevrolet Astro
11 van, V.I.N. 1GNDM19W4XB129948, to the Delancey Street Foundation for
12 a period of seven years (renewable thereafter at the discretion of
13 the Director, Mayor's Criminal Justice Council) for the
14 aforementioned purposes, for the amount of one dollar (\$1.00) per
15 annum, payable in full at lease inception; and, be it

16 FURTHER RESOLVED, That the Delancey Street Foundation shall
17 maintain insurance coverages, which shall include the City and County
18 as a named insured, and which shall be approved by the City and
19 County's Risk Manager, and the maintenance of such insurance shall be
20 an express condition of this lease.


