8 WHEREAS, The Department of Children, Youth and Their Families (DCYF) has been
9 charged with developing a strategic plan for implementing the recommendations of the Board
10 of Supervisors' Childhood Nutrition and Physical Activity Task Force; and,

11 WHEREAS, The task force recommendations, summarized in the January 2005 report
12 "Healthy Nutrition & Physical Activity for San Francisco's Children", address access to and
13 utilization of nutrition and physical activity opportunities for San Francisco's children and
14 youth; and,

15 WHEREAS, DCYF will convene an inter-agency committee representing the
16 Department of Public Health, Recreation and Park Department, Planning Department, San
17 Francisco Unified School District and other stakeholders to develop the strategic plan; and,

18 WHEREAS, The California Endowment has agreed to support the \$24,993 cost of
19 conducting the strategic planning process; and,

20 WHEREAS, DCYF will partner with Team-Up for Youth's expert staff and consultants to
21 help lead the inter-agency strategic planning process by providing a grant to Team Up for
22 Youth in the full amount of the California Endowment funding; and,

23 WHEREAS, There is no match requirement for this grant; and,


24 WHEREAS, The grant terms prohibit indirect costs; now, therefore, be it

2 the grant budget; and be it


3 FURTHER RESOLVED, That the City and County of San Francisco hereby authorizes
