7 ~~———— (b) ——— An analysis of revenue and taxation policies of the City and County of San Francisco~~
8 ~~and of comparable governmental jurisdictions.~~

9 ~~———— (c) ——— An analysis of San Francisco's revenue and taxation policies from the standpoint of such~~
10 ~~factors as equalizing the tax burden and spreading the tax base.~~

11 ~~———— (d) ——— An analysis of economic conditions in relation to revenue and taxation programs and~~
12 ~~policies of the City and County of San Francisco.~~

13 ~~———— (e) ——— Suggested criteria for selecting from among various available revenue and taxation~~
14 ~~sources and for determining the proportionate share each source should contribute toward the revenue~~


