14	Section 1. Findings. The Board of Supervisors of the City and County of San Francisco		
15	hereby finds and determines that:		
16	(a) On , 2005, at a duly notice public hearing, the Planning Commission		
17	in Motion No. , found that the proposed zoning reclassification and map amendment		
18	from RH-3 (Residential, Three-Family) to NC-1 (Neighborhood Commercial Cluster District)		
19	were consistent with the City's General Plan and with Planning Code Section 101.1(b). In		
20	addition, the Planning Commission, in Resolution No. , recommended that the Board		
21	of Supervisors adopt the zoning map amendment. Copies of said Resolution and Motion are		
22	on file with the Clerk of the Board of Supervisors in File No. and are incorporated
