2 **Resolution retroactively approving the contract modification between the City**  
3 **and County of San Francisco and Guardsmark LLC, to provide security services**  
4 **for the Human Services Agency, to extend the term by two month, for a revised**  
5 **period of December 1, 2008, through January 31, 2014, in the modified amount of**  
6 **\$21,226,260.**

8 WHEREAS, The City and County of San Francisco wishes to provide security  
9 services to its employees, clients and the general public at 20 locations; and,

10 WHEREAS, The Board of Supervisors approved this contract by Resolution No.  
11 201-08 and subsequent Ordinance No. 306-08 in 2008; and,

12 WHEREAS, The Human Services Agency wishes to extend this contract by two  
13 months until January 31, 2014 and add \$1,900,000 in order to complete the new  
14 request for proposal process resulting in a modified total contract amount of  
15 \$21,226,260; and,

16 WHEREAS, The City and County of San Francisco is providing financial support  
17 with Federal, State and General Funds; now, therefore, be it

18 RESOLVED, That the Board of Supervisors retroactively authorizes Executive  
19 Director of the Human Services Agency to approve the contract modification with  
20 Guardsmark LLC., to provide security services to the Human Services Agency for its  
21 employees, clients and the general public for the modified period of December 1, 2008,  
22 through January 31, 2014, in the amount of \$21,226,260; and, be it
