8 on oil imports from politically unstable countries, and

9 WHEREAS, The combustion of fossil fuels releases carbon dioxide into the  
10 atmosphere, which is warming the planet at an unprecedented rate, and

11 WHEREAS, Emissions from fossil fuels are responsible for poor air quality that impacts  
12 public health and the economy, and

13 WHEREAS, During the State of the Union Address, the President of the United States  
14 of America declared that our country is addicted to oil, and

15 WHEREAS, Addiction is defined as the state of being enslaved to a habit or practice or  
16 to something that is psychologically or physically habit-forming to such an extent that its  
17 cessation causes sever trauma, and

18 WHEREAS, San Francisco and California can help cure oil addiction by developing  
19 alternative and renewable energy sources to displace fossil fuels, and

20 WHEREAS, Proposition 87 on the November Ballot will help decrease dependence on  
21 oil, reduce air pollution and the respiratory diseases caused by airborne pollutants, and fund  
22 alternative energy development; now, therefore, be it

23 RESOLVED, That the Board of Supervisors endorses the passage on the November 7,  
24 2006 statewide General Election ballot of Proposition 87, the Clean Alternative Energy Act;


