3 **Resolution urging the Juvenile Probation Department, the Department of Children,**  
4 **Youth and their Families (DCYF) and the Mayor's Criminal Justice Council (MCJC), to**  
5 **research alternative funding sources; and in light of TANF (Temporary Aid to Needy**  
6 **Families) funds ending in 2003, plan for long-term sustainable dollars to fund services**  
7 **specific to girls involved with the Juvenile Justice System, or who are at risk of**  
8 **entering the System.**

10 WHEREAS, More girls are showing violent behaviors, and more girls are entering the  
11 juvenile justice system, and many at younger ages; and

12 WHEREAS, Girls face risk factors that are different from boys because of their gender,  
13 and girls needs are overlooked and under treated; and,

14 WHEREAS, Girls at risk of delinquency are typically poor and have grown up in a  
15 neighborhood with a high crime rate; and,

16 WHEREAS, Girls at risk of delinquency typically belong to an ethnic minority group;  
17 and,

18 WHEREAS, Girls at risk of delinquency typically have a history of poor academic  
19 performance, and may be high school drop outs; and,

20 WHEREAS, Of girls involved in the Juvenile Justice System, 40 to 70% have a past  
21 history of family abuse (physical, sexual or emotional), compared to 23 to 34% of girls in the  
22 general population; and,

23 WHEREAS, Girls accounted for 14% of all juvenile violent crime index arrests in 1994,  
24 an increase of 11% from 1985; and,

1           WHEREAS, Arrest rates for violent crime index offenses committed by girls increased  
2 125% from 1985 through 1994 while the rates for boys increased 67%; now, therefore, be it

3           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
4 urges the Juvenile Probation Department (JPD), the Department of Children, Youth and their  
5 Families (DCYF) and the Mayor's Criminal Justice Council (MCJC), to research alternative  
6 funding sources; and in light of TANF (Temporary Aid to Needy Families) funds ending in  
7 2003, plan for long-term sustainable dollars to fund services specific to girls involved with the  
8 Juvenile Justice System, or who are at risk of entering the System; and, be it

9           FURTHER RESOLVED, That the JPD, DCYF, and the MCJC report back to the full  
10 Board no later than March 15<sup>th</sup>, 2001 on their findings.




