RESOLVED, that the Examiner and the Chronicle, are newspapers of general circulation published in the City and County of San Francisco for the dissemination of local or telegraphic news and intelligence of a general character, having a bona fide circulation of at least 50,000 copies per calendar week, printed in the City and County on three or more days in a calendar week, is hereby designated as the official newspapers of the City and County of San Francisco, commencing July 1, 2006 for the publication of all official advertising of the City and County which is required by law, other than the provisions of Section 2.103 of the Charter as they relate to special meetings of the Board of Supervisors and its special or standing committees, to be published one time, and all official advertising of the City and County which is required by law to be published more than one, but not more than three times per week for a specified number of weeks, and, be it

FURTHER RESOLVED, that the Office of Contract Administration is hereby authorized to execute a contract with the Examiner and the Chronicle said contract must be in accordance with all the contracting requirements of the City and County of San Francisco.
