9 Section 1. The San Francisco Traffic Code is hereby amended by repealing Section
10 35.1, which reads as follows:

12 ~~of 22nd and Army Street during the hours of 9:00 p.m. on Friday and 4:00 a.m. on the following~~
13 ~~Saturday, and 9:00 p.m. on Saturday and 4:00 a.m. on the following Sunday, and during the summer~~
14 ~~months from June 15th to September 14th from 9:00 p.m. on Sunday to 4:00 a.m. on the following~~


