Ordinance amending the Planning Code to permit the use of California Debt Limit Allocation Committee tax-exempt bond financing and tax credits under the Tax Credit Allocation Committee for certain affordable housing projects that provide additional affordable units or deeper affordability levels than required by the Inclusionary Housing Ordinance; affirming the Planning Department's determination under the California Environmental Quality Act; making findings of public necessity, convenience, and general welfare findings under Planning Code, Section 302; and making findings of consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1.

Referred to the Planning Commission for findings of consistency with the General Plan; the eight priority policies of Planning Code, Section 101.1; and findings of public necessity, convenience, and welfare under Planning Code, Section 302. Referred to the Planning Department for environmental review. Referred to Mayor's Office of Housing and Community Development for informational purposes.

10/04/24; RESPONSE RECEIVED. Not defined as a project under CEQA Guidelines Sections 15378 and 15060(c)(2) because it would not result in a direct or indirect physical change in the environment. Physical projects will require separate environmental review.

10/30/24; RESPONSE RECEIVED. On October 24, 2024, the Planning Commission met and held a duly noticed hearing and recommended approval of the proposed legislation with modifications.

John Avalos (Council of Community Housing Advocates); Alex Landsberg; Patrick McNerney, President (Martin Building Company); John Kevlin (Reuben, Junius, and Rose LLP); Jane Natoli; Speaker; Mauricio Chavez (Northern California Carpenters Union); Speaker; Speaker; David Kim (SFYIMBY); Speaker; Alex Steiner; Brinna Morales (San Francisco Housing Action Coalition); Ace Washington; Jim Chappell (San Francisco Housing Action Coalition); shared various concerns regarding the ordinance matter.

Vice Chair Chen moved that this Ordinance be AMENDED, AN AMENDMENT OF THE WHOLE BEARING NEW TITLE, on Page 1, Lines 7-8, by inserting 'and require the Mayor's Office of Housing and Community Development to report on such projects;' on Page 3, Lines 7-17, by inserting '(e) Pursuant to Administrative Code Chapter 43, Article IX, the Mayor's Office of Housing & Community Development administers the Multifamily Securities Program and has adopted the Multifamily Securities Program Manual (the "Manual") for administering the issuance of tax exempt multifamily revenue bonds for affordable housing projects that have received an allocation from CDLAC and TCAC. Under the Manual, MOHCD monitors the regional allocation to the San Francisco Bay Area and competitiveness under TCAC and CDLAC regulations. Based on the availability of TCAC and CDLAC allocations and competitiveness within the Bay Area, MOHCD may request non-City funded affordable housing projects to temporarily delay an application for a TCAC and CDLAC allocation if there is an insufficient amount of allocation for City funded affordable housing that are ready for construction;' on Page 5, Line 24, through Page 6, Line 10, to read 'CDLAC and TCAC. Notwithstanding the provisions of subection 415.6 (h)(1) and (h)(2)(A) above, a project may use California Debt Limit Allocation Committee (CDLAC) tax-exempt bond financing, 4% tax credits under the Tax Credit Allocation Committee (TCAC), and tax credits allocated under the TCAC quidelines to help fund its obligations under Section 415.1 et seg. as long as the project provides at least one of the following: (i) 20% of the units as affordable to households at 50% of Area Median Income for on-site housing; (ii) 10% of the units as affordable to households at 50% of Area Median Income, and 30% of the units as affordable to households at 60% of Area Median Income for on-site housing; or (iii) the same number of on-site affordable units as required by the applicable on-site affordable housing requirement in this Section 415 et seq. plus an additional number of on-site affordable units equal to 25% of the applicable on-site affordable units as affordable to households at or below 80% of Area Median Income:' and on Page 6, Lines 16-23, by inserting '(3) Reporting. MOHCD shall monitor state and federal funding for 100% affordable housing projects, awards made by TCAC and CDLAC to 100% affordable housing projects in San Francisco. and any changes to the regulations of TCAC and CDLAC. MOHCD shall provide to the Inclusionary Housing Technical Advisory Committee, established in Administrative Code Chapter 5 Article XXIX, a written report of projects approved under Section 415.6(h)(2)(B), 100% affordable housing projects applying for tax exempt bond financing under CDLAC and tax credits under TCAC, and challenges for 100% affordable housing projects to obtain an award from CDLAC and TCAC.' Ordinance amending the Planning Code to permit the use of California Debt Limit Allocation Committee tax-exempt bond financing and tax credits under the Tax Credit Allocation Committee for certain affordable housing projects that provide additional affordable units or deeper affordability levels than required by the Inclusionary Housing Ordinance, and require the Mayor's Office of Housing and Community Development to report on such projects; affirming the Planning Department's determination under the California Environmental Quality Act; making public necessity, convenience, and welfare findings under Planning Code, Section 302; and making findings of consistency with the General Plan and the eight priority policies of Planning Code, Section 101.1.

Member Mahmood moved that this Ordinance be AMENDED, AN AMENDMENT OF THE WHOLE BEARING NEW TITLE, on Page 1, Line 1, to read 'Planning, Health Codes -Inclusionary Housing Ordinance, Non-Potable Water Exemption; on Page 1, Lines 8-11, by inserting 'amending the Health Code to exempt such affordable housing projects from compliance with the requirement that new buildings be constructed, operated, and maintained using alternate water sources for non-potable uses;' on Page 6, Lines 4-16, to read 'CDLAC and TCAC. Notwithstanding the provisions of subection 415.6 (h)(1) and (h)(2) (A) above, a project may use California Debt Limit Allocation Committee (CDLAC) tax-exempt bond financing, 4% tax credits under the Tax Credit Allocation Committee (TCAC), and tax credits allocated under the TCAC guidelines to help fund its obligations under Section 415.1 et seq. as long as the project provides at least one of the following: (i) 20% of the units as affordable to households at 50% of Area Median Income for on-site housing: (ii) 10% of the units as affordable to households at 50% of Area Median Income. and 30% of the units as affordable to households at 60% of Area Median Income for on-site housing; or (iii) the same number of on-site affordable units as required by the applicable on-site affordable housing requirement in this Section 415 et seq. or any temporary reduction as set forth in Sections 415A et seq. or 415B et seq., plus an additional number of on-site affordable units equal to 25% of the applicable on-site affordable units as affordable to households at or below 80% of Area Median Income;' on Page 7, Line 6, through Page 8, Line 15, by adding an amendment to Health Code, Section 12C.2, within the definition of "Development Project" to read 'Development Project does not include (1) any 100% Affordable Housing Project, 100% Permanent Supportive Housing Project, housing project funded or constructed pursuant to the HOPE SF Program sponsored and developed by the San Francisco Housing Authority and either the Mayor's Office of Housing and Community Development or the Office of Community Investment and Infrastructure, or housing project that is issued a First Construction Document, as that term is defined in Building Code Section 107A.13.1, prior to July 1, 2025, uses California Debt Limit Allocation Committee tax-exempt bond financing and tax credits under the Tax Credit Allocation Committee, as set forth in Planning Code Section 415.6(h)(2)(B), and provides at least 100 total on-site affordable units;' and making confoming and clerical amendments throughout the ordinance text.
