3 **Resolution retroactively approving the grant agreement between the City and County of**
4 **San Francisco and Children’s Council of San Francisco for the provision of Early Care**
5 **Workforce Compensation and Administrative Services to support the City’s**
6 **implementation of the San Francisco Citywide Plan for Early Care and Education (ECE)**
7 **Workforce Development and Compensation Initiatives for the period of October 1, 2022,**
8 **through June 30, 2025, in an amount not to exceed \$164,346,004.**

10 WHEREAS, The City and County of San Francisco, wishes to provide Early Care
11 Workforce Compensation and Administrative Services by administering fund disbursement,
12 monitor grant determination, staffing, and system development; and

13 WHEREAS, The Department of Early Childhood (“DEC”), under the auspices of the
14 Human Services Agency, conducted a Request for Proposals for these services in April 2022;
15 and

16 WHEREAS, Children’s Council of San Francisco submitted a responsive and
17 responsible proposal and was awarded the grant in August 2022 in an amount not to exceed
18 \$164,346,004; and

19 WHEREAS, DEC’s Executive Director provides a presentation at the June 2023
20 department budget hearing reconciling the CARES 3.0 and Early Educator Salary Support
21 grant program expenditures to ensure proper disbursement of wages or stipends to early
22 educators, now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby retroactively approves award of this
24 grant with Children’s Council of San Francisco to provide Early Care Workforce

1 Compensation and Administrative Services, for the period of October 1, 2022, through
2 June 30, 2025, in the amount of \$164,346,004; and, be it

3 FURTHER RESOLVED, That within thirty (30) days of the grant agreement being fully
4 executed by all parties, DEC shall provide the final grant to the Clerk of the Board for inclusion
5 into the official file.




