9 Section 1. The San Francisco Administrative Code is hereby amended by repealing
10 Sections 13.70 through 13.75, in their entirety.

11 ~~**SEC. 13.70. AUTHORITY OF BOARD OF SUPERVISORS.**~~

12 ~~*The Board of Supervisors of the City and County of San Francisco under authority of Sections*~~
13 ~~*4300 through 4305 of the Penal Code of the State of California, hereby establishes an advisory*~~
14 ~~*committee on adult detention*~~

16 ~~**SEC. 13.71. MEMBERS.**~~

17 ~~*There shall be nine members of the committee. Three shall be appointed by the Board of*~~
18 ~~*Supervisors, three by the Sheriff, and three by the presiding judge of the Superior Court. One of the*~~
19 ~~*members appointed by the presiding judge shall be a member of the State Bar. One of the members*~~
20 ~~*appointed by the Board of Supervisors and one of the members appointed by the Sheriff shall be*~~
21 ~~*nominated by the Health Commission*~~

23 ~~**SEC. 13.72. TERM OF OFFICE.**~~

24 ~~*The members of the committee shall hold office for four years and until their successors are*~~
25 ~~*appointed and qualify. Of those first appointed by the Sheriff, Superior Court judge, and the Board of*~~

1 ~~Supervisors, one shall hold office for two years, and one for four years; and the respective terms of the~~
2 ~~members first appointed shall be determined by lot as soon as possible after their appointment. When a~~
3 ~~vacancy occurs in the committee by expiration of the term of office of any member thereof, his~~
4 ~~successor shall be appointed to hold office for a term of four years. When a vacancy occurs for any~~
5 ~~other reason, the appointee shall hold office for the unexpired term of his predecessor~~

7 **~~SEC. 13.73. COMPENSATION.~~**

8 ~~Members of the committee shall serve without compensation, but shall be allowed their~~
9 ~~reasonable expenses as approved by the presiding judge of the Superior Court. Such expenses shall be~~
10 ~~a charge upon the county in which the court has jurisdiction, and shall be paid out of the county~~
11 ~~treasury upon a written order of the judge of the Superior Court directing the county auditor to draw a~~
12 ~~warrant upon the City and County Treasurer for the specified amount of such expenses. All orders by~~
13 ~~the Superior Court judge upon the City and County Treasurer shall be filed in duplicate with the City~~
14 ~~and County Board of Supervisors and Sheriff~~

16 **~~SEC. 13.74. ANNUAL REPORT.~~**

17 ~~The committee shall file a report within 90 days after the 31st day of December of the calendar~~
18 ~~year for which such report is made, copies of which shall be filed with the City and County Board of~~
19 ~~Supervisors, the presiding judge, the Sheriff, the Board of Corrections, and the Attorney General.~~
