15 since their inception and deems participation in these programs as vital to the continued well-
16 being of its residents and visitors, property and environment; and,

17 WHEREAS, the Emergency Operation Center grant program provides federal funds to
18 local government to upgrade their emergency operations centers; and,

19 WHEREAS, The State of California requires that San Francisco's agents be named in
20 a governing body resolution, now, therefore, be it

21 **RESOLVED, That the Board of Supervisors of the City and County of San Francisco, a**
22 **public entity established under the laws of the State of California, authorizes the Executive**
23 **Director of the Department of Emergency Management, or in his or her absence, the Chief**
24 **Financial Officer of the Department of Emergency Management, or the Deputy Director of the**
25 **Department of Emergency Management, to execute for and on behalf of the City and County**
