3 BEVERAGE CONTROL LICENSE TO BRUCE L. CEARLOCK FOR ALLEYCORP, INC. FROM 243
4 O'FARRELL STREET TO 493 BROADWAY STREET, WILL SERVE THE CONVENIENCE OF THE PEOPLE

8 WHEREAS, Bruce L. Cearlock is seeking transfer of a Type 48 on-sale general public premises alcoholic
9 beverage control license for Alleycorp, Inc. located at 493 Broadway Street; and,

10 WHEREAS, The City Planning Department has verified that the area is properly zoned; and,

11 WHEREAS, The Police Department recommends that the liquor license application be approved; now,
12 therefore, be it

13 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,
14 the Board of Supervisors of the City and County of San Francisco hereby determines with conditions and for the
15 foregoing reasons that the transfer of a Type 48 on-sale general public premises alcoholic beverage control license
16 to Bruce L. Cearlock for Alleycorp, Inc., located at 493 Broadway Street, will serve the convenience of the people
17 of the City and County of San Francisco.

18 Conditions: 1) Entertainment provided shall not be audible beyond the area under the control of the
19 licensee. 2) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over
20 which they have control. 3) There shall be no exterior advertising of any kind, depicting topless or nude persons,
21 entertainers or dancers, including advertising directed to the exterior from within. 4) The sale of beer or wine off of
22 the premises is strictly prohibited.




