

1 [Liquor License Transfer - 629 Union Street - Giovanni Italian Specialties]

3 **Resolution determining that the premise-to-premise transfer of a Type-21 off-sale**  
4 **general beer, wine, and distilled spirits liquor license to Giovanni Specialties LLC,**  
5 **doing business as Giovanni Italian Specialties located at 629 Union Street**  
6 **(District 3), will serve the public convenience or necessity of the City and County**  
7 **of San Francisco, in accordance with California Business and Professions Code,**  
8 **Section 23958.4; and requesting that the California Department of Alcoholic**  
9 **Beverage Control impose conditions on the issuance of the license.**

11 WHEREAS, Giovanni Specialties LLC is seeking the premise-to-premise transfer  
12 of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to do  
13 business as Giovanni Italian Specialties located at 629 Union Street; and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero (0) protests and zero (0)  
17 letters of support with the Department of Alcoholic Beverage Control under California  
18 Business and Professions Code, Section 24013, and recommends that the Department  
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) alcoholic beverages shall be permitted between the hours of 10:00 a.m.  
22 and 8:00 p.m. daily; 2) no distilled spirits shall be sold in bottles or containers smaller  
23 than 600 milliliters; and 3) petitioner(s) shall actively monitor the area under their control  
24 in an effort to prevent the loitering of persons on any property adjacent to the licensed  
25 premises as depicted on the most-recently certified ABC-253; now, therefore, be it

1           RESOLVED, That in accordance with California Business and Professions Code,  
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3 hereby determines that the premise-to-premise transfer of a Type-21 off-sale general  
4 beer, wine, and distilled spirits liquor license to Giovanni Specialties LLC, doing  
5 business as Giovanni Italian Specialties located at 629 Union Street (District 3), will  
6 serve the public convenience or necessity of the City and County of San Francisco; and,  
7 be it

8           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
9 San Francisco hereby endorses and adopts the recommendations of the Police  
10 Department listed above and recommends that the Department of Alcoholic Beverage  
11 Control issue the license with those conditions.
