10 9th Avenue, both sides, between Judah and Kirkham Streets (1400 block)

11 Kirkham Street, both sides, between 9th and 10th Avenues (500 block)

12 RESIDENTIAL PERMIT PARKING AREA "O" (2-HOUR TIME LIMIT, 8 AM - 6 PM,  
13 MONDAY THROUGH FRIDAY) - ESTABLISH

14 16th Avenue, both sides, between Santiago Street and Cecilia Avenue (northern  
15 portion of 2300 block)

16 RESIDENTIAL PERMIT PARKING AREA "W" (1-HOUR TIME LIMIT, 8 AM - 6 PM,  
17 MONDAY THROUGH FRIDAY) - ESTABLISH

18 26th Street, both sides, between Hampshire and York Streets (2800 block)


