3 Ordinance authorizing settlement of two lawsuits, which were filed by Earnest  
4 Henderson, Janel Gotta, Aaron Rauls, Michael Perez, Arturo Pleitez, and Mack Woodfox  
5 against the City and County of San Francisco and its employees for a total amount of  
6 \$217,000.00; the first lawsuit was filed on January 14, 2005 in the United States District  
7 Court for the Northern District of California, Case No. C05-0280 VRW/WAF, entitled  
8 Earnest Henderson, et al., v. City and County of San Francisco, et al.; the second  
9 lawsuit was filed on October 18, 2005 in the United States District Court for the  
10 Northern District of California, Case No. C05-4220 VRW; entitled Mack Woodfox v. City  
11 and County of San Francisco, et al.; the above total settlement amount also includes all  
12 claims for costs and attorneys' fees.

13  
14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The City Attorney is hereby authorized to settle the actions entitled Earnest  
16 Henderson, et al., v. City and County of San Francisco, et al.," United States District Court for  
17 the Northern District of California, Case No. C05-0280 VRW/WAF, and "Mack Woodfox v. City  
18 and County of San Francisco, et al.," United States District Court for the Northern District of  
19 California, Case No. C05-4220 VRW, by the payment of a total amount of \$217,000.00, which  
20 includes all claims for costs and attorneys' fees.

21 Section 2. The action entitled Earnest Henderson, et al., v. City and County of San  
22 Francisco, et al. was filed in the United States District Court for the Northern District of  
23 California on January 14, 2005 and the following parties were named in the lawsuit: Plaintiffs  
24 Earnest Henderson, Janel Gotta, Aaron Rauls, Michael Perez, and Arturo Pleitez; Defendants


