2 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, POPULATION HEALTH AND  
3 PREVENTION, COMMUNITY HEALTH PROMOTION AND PREVENTION, TO ACCEPT AND  
4 EXPEND GRANT FUNDS OF \$449,929 FROM THE STATE OF CALIFORNIA OFFICE OF TRAFFIC  
5 SAFETY FOR THE SAN FRANCISCO PEDESTRIAN SAFETY PROGRAM AND TO ENTER INTO AN  
6 AGREEMENT WHICH DOES NOT INCLUDE INTELLECTUAL PROPERTY INDEMNIFICATION  
7 AND FALSE CLAIMS CLAUSES.

8 WHEREAS, The Department of Public Health has applied for and been awarded a grant from  
9 The State of California Office of Traffic Safety, in the amount of \$449,929, for the San Francisco  
10 Pedestrian Safety Program; and,

11 WHEREAS, As a condition of receiving the grant funds, The State of California Office of  
12 Traffic Safety requires the City to enter into an agreement (the "Agreement"), a copy of which is on file  
13 with the Clerk of the Board of Supervisors in File No. 000961; and

14 WHEREAS, The Agreement does not contain certain provisions described below, which are  
15 required under the Administrative Code unless waived by the Board of Supervisors; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$38,166; and

17 WHEREAS, The Parking and Traffic Commission and the Department of Health are  
18 collaborating on data collection and analysis in this study to insure reliability of the information; now,  
19 therefore be it

20 RESOLVED, That the Department of Public Health is hereby authorized to accept and expend  
21 the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it

22 FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement  
23 on behalf of the City; and, be it






