3 **Resolution appointing Jason Oringer, Alicia Culver, Abigail Levine, Laura Juran, Dale**  
4 **Jiajun Wen, terms ending December 17, 2007, to the Sweatfree Procurement Advisory**  
5 **Board, residency requirement waived.**

7         RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the  
9 Sweatfree Procurement Advisory Board, pursuant to the provisions of Board of Supervisors  
10 Ordinance No. 223-05, for the term specified:

11             Jason Oringer, new appointment, seat 1, must have significant experience representing  
12 employees in labor matters, for the unexpired portion of a two-year term ending December 17,  
13 2007.

14             Alicia Culver (residency requirement waived), new appointment, seat 2, must have  
15 significant experience acquiring goods or services for a public entity, for the unexpired portion  
16 of a two-year term ending December 17, 2007.

17             Abigail Levine, new appointment, seat 3, must have significant experience as an  
18 advocate for human rights or the poor, for the unexpired portion of a two-year term ending  
19 December 17, 2007.

20             Laura Juran, new appointment, seat 4, must be a member of the public, for the  
21 unexpired portion of a two-year term ending December 17, 2007.

22             Dale Jiajun Wen, new appointment, seat 5, must be a member of the public, for the unexpired  
23 portion of a two-year term ending December 17, 2007; and, be it

24             **FURTHER RESOLVED**, That the Board of Supervisors makes the following findings:

- 1 1. The membership of the Sweatfree Procurement Advisory Board has a goal to be  
2 representative of the diversity of the City and County of San Francisco.
- 3 2. Applicant Alicia Culver, a new appointee, who is not a resident of San Francisco, is  
4 a person with experience that uniquely qualifies him/her to serve on the Sweatfree  
5 Procurement Advisory Board.
- 6 3. The Sweatfree Procurement Advisory Board has attempted to fill the position, for  
7 which Alicia Culver was nominated, with an individual who is a City resident and  
8 who has the specific experience, skills, and qualifications, but has been unable to  
9 do so at this time. The Rules Committee has certified that Alicia Culver is qualified  
10 to serve on the Sweatfree Procurement Advisory Board.
- 11 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
12 other possible representative, who is a resident of San Francisco and who has the  
13 specific experience, skills, or qualifications possessed by this applicant, and who is  
14 willing to serve on the Sweatfree Procurement Advisory Board at this time; and, be  
15 it

16 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
17 requirement for Alicia Culver, as allowed in cases where no qualified City resident, willing to  
18 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
19 appointed to boards, commissions, and advisory bodies established by legislative act of the  
20 Board of Supervisors to be resident(s) of the City and County of San Francisco.




