

1 [Initiative Ordinance – Business and Tax Regulations Code – Enact Gross Receipts Tax and
2 Phase Out Payroll Expense Tax]

3 **Motion ordering submitted to the voters an "Ordinance amending the Business and**
4 **Tax Regulations Code to: 1) enact a new Article 12-A-1 (Gross Receipts Tax**
5 **Ordinance) to impose a gross receipts tax and an administrative office tax on persons**
6 **engaging in business activities in San Francisco; 2) amend Article 12-A (Payroll**
7 **Expense Tax Ordinance) to reduce business payroll expense tax rates based on the**
8 **amount of gross receipts tax collected under Article 12-A-1 (Gross Receipts Tax**
9 **Ordinance); 3) amend Article 12 (Business Registration Ordinance) to establish**
10 **business registration fees based on gross receipts and amend the current business**
11 **registration fees to generate approximately \$28.5 million in estimated additional**
12 **revenue; 4) amend Article 12-A (Payroll Expense Tax Ordinance) to add a sunset date**
13 **to the surplus business tax revenue credit; and 5) amend Article 6 (Common**
14 **Administrative Provisions) to establish requirements for filing a tax return under Article**
15 **12-A-1 (Gross Receipts Tax Ordinance), establish penalties for non-filing, and amend**
16 **the requirements for filing payroll expense tax returns and penalties for non-filing to**
17 **conform to the new gross receipts tax" at an election to be held on November 6, 2012.**

19 **MOVED, That the Board of Supervisors hereby submits the following Ordinance to the**
20 **voters of the City and County of San Francisco, at an election to be held on November 6,**
21 **2012.**

23 **Ordinance amending the Business and Tax Regulations Code to: 1) enact a new**
24 **Article 12-A-1 (Gross Receipts Tax Ordinance) to impose a gross receipts tax and an**
25 **administrative office tax on persons engaging in business activities in San Francisco;**

1 2) amend Article 12-A (Payroll Expense Tax Ordinance) to reduce business payroll
2 expense tax rates based on the amount of gross receipts tax collected under
3 Article 12-A-1 (Gross Receipts Tax Ordinance); 3) amend Article 12 (Business
4 Registration Ordinance) to establish business registration fees based on gross
5 receipts and amend the current business registration fees to generate approximately
6 \$28.5 million in estimated additional revenue; 4) amend Article 12-A (Payroll Expense
7 Tax Ordinance) to add a sunset date to the surplus business tax revenue credit; and
8 5) amend Article 6 (Common Administrative Provisions) to establish requirements for
9 filing a tax return under Article 12-A-1 (Gross Receipts Tax Ordinance), establish
10 penalties for non-filing, and amend the requirements for filing payroll expense tax
11 returns and penalties for non-filing to conform to the new gross receipts tax.

14 Be it ordained by the People of the City and County of San Francisco:

15
16 Section 1. The Planning Department has determined that the actions contemplated in
17 this Ordinance comply with the California Environmental Quality Act (California Public
18 Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the
19 Board of Supervisors in File No. _____ and is incorporated herein by reference.
20

21 Section 2. Pursuant to Article XIIC of the Constitution of the State of California, this
22 Ordinance shall be submitted to the qualified electors of the City and County of
23 San Francisco, at the November 6, 2012 consolidated general election.

1 Section 3. The San Francisco Business and Tax Regulations Code is hereby amended
2 by adding Article 12-A-1 to read as follows:

3
4 **SEC. 950. FINDINGS AND PURPOSE.**

5 *The voters hereby find and declare as follows:*

6 *1. San Francisco is the only major city in California that levies its entire business tax on*
7 *payroll expense. This exclusive payroll-based tax discourages job creation and economic growth,*
8 *lowers wages, and provides an unstable revenue stream.*

9 *2. San Francisco currently charges a flat rate on its payroll expense tax base. Instituting a*
10 *tiered rate structure, in which businesses are taxed based on their gross receipts, will better distribute*
11 *the tax burden according to a business's ability to pay.*

12 *3. Gross receipts is the most common business tax base among California's largest cities.*

13 *4. Amending San Francisco's business tax system to include a gross receipts tax will promote*
14 *revenue stability by diversifying the tax base.*

15 *5. The rate schedules and the small business exemption for businesses with receipts under*
16 *\$1,000,000 provide particular tax relief to small businesses.*

17 *6. The legislation will gradually phase in the new gross receipts tax over a five-year period,*
18 *beginning in tax year 2014, to allow businesses time to adjust to the change and to minimize the risk to*
19 *the City and to taxpayers of instability in City revenues during the transition from the payroll expense*
20 *tax to a gross receipts tax.*

21 *7. Also beginning in tax year 2014, the payroll expense tax will be adjusted, over the same*
22 *period, in increments that are consistent with the phase in of the gross receipts tax.*

23 *8. Each year during the phase-in period, the formula dictates an increase in the gross receipts*
24 *tax rate and an adjustment in the payroll expense tax rate that is expected to reduce the payroll expense*
25 *tax rate to zero by or before 2018. The Controller will calculate the annual increase in the gross*

1 receipts tax rate and the adjustment in the payroll expense tax rate by applying formulas specified in
2 this legislation.

3
4 **SEC. 951. SHORT TITLE.**

5 This Article shall be known as the "Gross Receipts Tax Ordinance" and the tax this Article
6 imposes shall be known as the "Gross Receipts Tax."

7
8 **SEC. 952. DEFINITIONS.**

9 Except where the context otherwise requires, the terms used in this Article shall have the
10 meanings given to them in Sections 6.2-1 et seq. of Article 6 and in Article 12-A.

11
12 **SEC. 952.1. ADVANCE PAYMENT.**

13 "Advance payment" means a nonrefundable payment for the purchase of property or services to
14 be delivered or performed in the future.

15
16 **SEC. 952.2. CASH DISCOUNT.**

17 "Cash discount" means a deduction from the invoice price of goods or charge for services
18 which is allowed if the bill is paid on or before a specified date, or paid in cash rather than by credit
19 card.

20
21 **SEC. 952.3. GROSS RECEIPTS.**

22 (a) "Gross receipts" means the total amounts received or accrued by a person from whatever
23 source derived, including, but not limited to, amounts derived from sales, services, dealings in
24 property, interest, rent, royalties, dividends, licensing fees, other fees, commissions and distributed
25 amounts from other business entities. Except as otherwise specifically provided in this Article, gross

1 receipts includes but is not limited to all amounts that constitute gross income for federal income tax
2 purposes. Except as otherwise specifically provided in this Article, gross receipts includes all receipts,
3 cash, credits and property of any kind or nature and including any amount for which credit is allowed
4 by the seller to the purchaser, without any deduction therefrom on account of the cost of the property
5 sold, the cost of materials used, labor or service costs, interest paid or payable, losses or any other
6 expense whatsoever, except that cash discounts allowed or taken on sales shall not be included as gross
7 receipts. Gross receipts, including advance payments, shall be included in a taxpayer's gross receipts
8 at the time such receipts are recognized as gross income for federal income tax reporting purposes.

9 (b) "Gross receipts" with respect to any lease or rental shall include payment for any services
10 that are part of the lease or rental, whether received in money or otherwise, that are paid to, on behalf
11 of, or for the benefit of, the lessor, and all receipts, cash, credits, property of any kind or character and
12 the fair market value of services so paid or rendered by the lessee.

13 (c) Treatment of Taxes. "Gross receipts" shall not include the amount of any federal, state, or
14 local tax imposed on or with respect to retail sales whether imposed upon the retailer or upon the
15 purchaser and regardless of whether the amount of tax is stated as a separate charge, or such part of
16 the sales price of any property previously sold and returned by the purchaser to the seller which is
17 refunded by the seller by way of cash or credit allowances given or taken as part payment on any
18 property so accepted for resale. Gross receipts shall also not include any federal, state or local tax
19 imposed upon a person for which that person is reimbursed by means of a separately stated charge to a
20 purchaser, lessee, licensee or customer. Gross receipts shall not include any amount of third-party
21 taxes that a taxpayer collects from or on behalf of the taxpayer's customers and remits to the
22 appropriate governmental entity imposing such tax. Gross receipts shall not include any tax refunds
23 received by a person from a governmental entity. Gross receipts shall include any federal, state or
24 local tax not specifically excluded in this subsection.

1 (d) "Gross receipts" shall not include any amount received from or charged to any person that
2 is a related entity to the taxpayer. Nor shall gross receipts include any grants received from
3 governmental entities or any gifts. Gross receipts shall not include any investment receipts.
4 "Investment receipts" includes interest, dividends, capital gains, other amounts received on account of
5 financial instruments, and distributions from business entities, provided such items are directly derived
6 exclusively from the investment of capital and not from the sale of property other than financial
7 instruments, or from the provision of services, to any person. Gross receipts also shall not include any
8 allocations of income or gain, or distributions (such as dividends, interest and other returns on capital)
9 from an entity treated as a pass-through entity for federal income tax purposes, provided such
10 allocations or distributions are derived exclusively from an investment in such entity, and not from any
11 other property sold to, or services provided to, such entity. Any gross receipts of a pass-through entity
12 which is subject to the gross receipts tax shall not also constitute gross receipts of any owner of that
13 entity.

14 (e) Notwithstanding the provisions of subsection (a), "gross receipts" from the sale or exchange
15 of stocks or other similar written instruments evidencing a right to participate in the assets of any
16 business, or of bonds or other evidence of indebtedness, or of any other marketable securities
17 (collectively referred to in this Article as "financial instruments"), or of any real property, shall not
18 include the cost to acquire the financial instrument(s), or real property, sold or otherwise exchanged or
19 converted. Nor shall "gross receipts" include the amount received by the original issuer of a financial
20 instrument in exchange for such issuance. To the extent that any loss on the sale or exchange of
21 financial instruments reduces the gross income of a person for federal income tax purposes in the year
22 the loss is incurred, that loss shall reduce gross receipts from the sale or exchange of financial
23 instruments, but in no event shall those receipts be less than zero, and in no event may any such loss be
24 carried back or carried forward to reduce gross receipts in a tax year other than that in which the loss
25 was incurred.

1 (f) No person shall be deemed to be engaging in business in the City if that person is an
2 individual whose only gross receipts within the City are derived from investments of that individual's
3 own funds in financial instruments. Gross receipts of an individual shall not include interest,
4 dividends, capital gains and similar items or investment income earned from the investment of that
5 individual's own capital.

6 (g) For purposes of this Article and Article 12, and notwithstanding Section 6.2-12 of Article 6,
7 no person shall be deemed to be engaging in business within the City if its activities in the City consist
8 solely of one or more of the following:

9 (1) contracting with, acting through, or otherwise using the services of, any investment
10 advisor or affiliate thereof which is not a related entity;

11 (2) maintaining documents of formation, incorporation, or registration within the City;

12 (3) being an owner, member, or other participant in an entity engaging in business
13 within the City which is a pass-through entity for federal income tax purposes; or

14 (4) having trustees or directors who meet or reside within the City.

15
16 **SEC. 952.4. NAICS CODE.**

17 "NAICS code" means the numerical classification for business activities established in the
18 North American Industry Classification System used by federal governmental agencies to classify
19 business establishments; references in this Article to particular numerical NAICS codes are intended to
20 apply the definitions and descriptions adopted in that system as of the effective date of this Article.

21
22 **SEC. 952.5. RELATED ENTITY.**

23 A person is a "related entity" to a taxpayer if that person and the taxpayer are permitted or
24 required by the California Franchise Tax Board under Section 25102 et seq. of the California Revenue
25 and Taxation Code, or any successor, to have their income reflected on the same combined report. For

1 purposes of this Article, if two or more persons derive gross receipts solely from sources within
2 California, and their business activities are such that, if conducted both within and outside California,
3 a combined report would be required under the California Revenue and Taxation Code, or any
4 successor, then those persons are related entities regardless of whether they file a combined report
5 under the California Revenue and Taxation Code, or successor.

6
7 **SEC. 952.6. SALE AND SELL.**

8 "Sale" and "sell" mean the making of any transfer of title, in any manner or by any means
9 whatsoever, to property for a price, and to the serving, supplying or furnishing, for a price, of any
10 property fabricated or made at the special order of consumers who do or who do not furnish directly or
11 indirectly the specifications or materials therefor. A transaction whereby the possession of property is
12 transferred but the seller retains the title as a security for the payment of the price shall likewise be
13 deemed a sale.

14
15 **SEC. 953. IMPOSITION OF GROSS RECEIPTS TAX.**

16 (a) Except as otherwise provided under this Article, the City imposes and every person
17 engaging in business within the City shall pay an annual gross receipts tax measured by the person's
18 gross receipts from all taxable business activities attributable to the City. A person's liability for the
19 gross receipts tax shall be calculated according to Sections 953.1 through 953.7.

20 (b) The gross receipts tax is a privilege tax imposed upon persons engaging in business within
21 the City for the privilege of engaging in a business or occupation in the City. The gross receipts tax is
22 imposed for general governmental purposes. Proceeds from the tax shall be deposited in the City's
23 general fund and may be expended for any purposes of the City.

24 (c) The voters intend by adopting this measure to authorize application of the gross receipts tax
25 in the broadest manner consistent with the provisions of this Article and the requirements of the

1 California Constitution, the United States Constitution, and any other applicable provision of federal
2 and state law.

3 (d) The gross receipts tax imposed under this Article is in addition to the payroll expense tax
4 imposed under Article 12-A. Persons not otherwise exempt from the gross receipts tax or payroll
5 expense tax shall pay both taxes. Persons exempt from either the gross receipts tax or payroll expense
6 tax, but not both, shall pay the tax from which they are not exempt.

7 (e) Except for subsection (d) of this Section, the tax on Administrative Office Business Activities
8 imposed by Section 953.8 is intended as a complementary tax to the gross receipts tax, and shall be
9 considered a gross receipts tax for purposes of this Article.

10 (f) For a five year period beginning in 2015, the Treasurer, Controller, and Chief Economist
11 shall jointly prepare an annual report to the Mayor and Board of Supervisors on the implementation of
12 the measure. The report shall include projections of collections of the gross receipts tax, compare
13 these projections to those anticipated in preparation of the measure, and outline impacts of the
14 measure on San Francisco's economy and business community. The report may recommend policy,
15 administrative, or technical changes for the consideration of the Mayor and Board of Supervisors that
16 further the goals established in the measure.

17
18 **SEC. 953.1. GROSS RECEIPTS TAX APPLICABLE TO RETAIL TRADE; WHOLESALE**
19 **TRADE; AND CERTAIN SERVICES.**

20 (a) The base gross receipts tax rate provided by this Section is applicable to the business
21 activities of retail trade, wholesale trade, and certain services. Commencing on the operative date of
22 the Gross Receipts Tax Ordinance, the Controller shall compute the tax rate in accordance with
23 Section 959, but the base tax rate provided by this Section is:

24 0.075% (e.g., \$0.75 per \$1,000) for gross receipts between \$0 and \$1,000,000

25 0.100% (e.g., \$1 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

1 0.135% (e.g., \$1.35 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

2 0.160% (e.g., \$1.60 per \$1,000) for gross receipts over \$25,000,000

3 (b) Retail trade includes the activity of retailing any type of personal property, generally
4 without significantly transforming its characteristics, and rendering services incidental to the retail
5 sale of property; it includes business activity described in NAICS codes 44 and 45.

6 (c) Wholesale trade includes the activity of wholesaling property, generally without
7 transformation, and rendering services incidental to the sale of property on a wholesale basis; it
8 includes business activity described in NAICS code 42.

9 (d) Certain services includes the repair and maintenance services, personal and laundry
10 services, and religious, grantmaking, civic, professional and similar organizations that are not
11 otherwise exempt; it includes business activity described in NAICS codes 811, 812 and 813.

12 (e) The amount of gross receipts from retail trade activities and from wholesale trade activities
13 subject to the gross receipts tax shall be one-half of the amount determined under Section 956.1 plus
14 one-half of the amount determined under Section 956.2.

15 (f) The amount of gross receipts from certain services activities subject to the gross receipts tax
16 shall be the total amount determined under Section 956.2.

17
18 **SEC. 953.2. GROSS RECEIPTS TAX APPLICABLE TO MANUFACTURING;**

19 **TRANSPORTATION AND WAREHOUSING; INFORMATION; BIOTECHNOLOGY; CLEAN**
20 **TECHNOLOGY; AND FOOD SERVICES.**

21 (a) The base gross receipts tax rate provided by this Section is applicable to the business
22 activities of manufacturing, transportation and warehousing, information, biotechnology, clean
23 technology, and food services. Commencing on the operative date of the Gross Receipts Tax
24 Ordinance, the Controller shall compute the tax rate in accordance with Section 959, but the base tax
25 rate provided by this Section is:

1 0.125% (e.g., \$1.25 per \$1,000) for gross receipts between \$0 and \$1,000,000

2 0.205% (e.g., \$2.05 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

3 0.370% (e.g., \$3.70 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

4 0.475% (e.g., \$4.75 per \$1,000) for gross receipts over \$25,000,000

5 (b) Manufacturing includes the activity of transforming materials, substances or components
6 into new products by mechanical, physical or chemical means; it includes the activity of assembling
7 component parts of manufactured products; it includes business activity described in NAICS codes 31,
8 32 and 33.

9 (c) Transportation and warehousing includes the activities of providing transportation of
10 passengers and/or goods, warehousing and storage for goods, scenic and sightseeing transportation,
11 and support activities related to modes of transportation; it includes business activity described in
12 NAICS codes 48 and 49.

13 (d) Information includes producing and distributing information or cultural products;
14 providing the means to transmit or distribute those products; and processing data; it includes business
15 activity described in NAICS code 51.

16 (e) For purposes of this Article, biotechnology includes the activity of biotechnology business
17 as defined in Section 906.1 of Article 12-A, and clean technology includes the activity of clean
18 technology business as defined in Section 906.2 of Article 12-A.

19 (f) Food services includes the activity of preparing meals, snacks and/or beverages to customer
20 order for immediate on-premises or off-premises consumption; it includes drinking places; it includes
21 business activity described in NAICS code 722.

22 (g) The amount of gross receipts from all business activities described in this Section subject to
23 the gross receipts tax shall be one-half of the amount determined under Section 956.1 plus one-half of
24 the amount determined under Section 956.2.

1 **SEC. 953.3. GROSS RECEIPTS TAX APPLICABLE TO ACCOMMODATIONS; UTILITIES;**
2 **AND ARTS, ENTERTAINMENT AND RECREATION.**

3 (a) The base gross receipts tax rate provided by this Section is applicable to each of the
4 following business activities: accommodations; utilities; and arts, entertainment and recreation.

5 Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller shall compute
6 the tax rate in accordance with Section 959, but the base tax rate provided by this Section is:

7 0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000

8 0.325% (e.g., \$3.25 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

9 0.325% (e.g., \$3.25 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

10 0.400% (e.g., \$4 per \$1,000) for gross receipts over \$25,000,000

11 (b) Accommodations includes the activity of providing lodging or short-term accommodations
12 for travelers, vacationers, or others; it includes business activity described in NAICS code 721.

13 (c) Utilities includes the activities of the generation, transmission and distribution of electric
14 power, the distribution of natural gas, the provision and distribution of steam supply, the treatment and
15 distribution of water supply, and the removal of sewage; it includes business activity described in
16 NAICS code 22; it excludes establishments primarily engaged in waste management services.

17 (d) Arts, entertainment and recreation include the activity of operating facilities or providing
18 services to meet cultural, entertainment or recreational interests of customers or patrons; it includes
19 business activity described in NAICS code 71.

20 (e) The amount of gross receipts and from accommodations subject to the gross receipts tax
21 shall be the total amount of gross receipts derived from or related to properties located or used within
22 the City.

23 (f) The amount of gross receipts from utilities subject to the gross receipts tax shall be one-half
24 of the amount determined under Section 956.1 plus one-half of the amount determined under
25 Section 956.2.

1 (g) The amount of gross receipts from arts, entertainment and recreation subject to the gross
2 receipts tax shall be the total amount determined under Section 956.2.

3
4 **SEC. 953.4. GROSS RECEIPTS TAX APPLICABLE TO PRIVATE EDUCATION AND HEALTH**
5 **SERVICES; ADMINISTRATIVE AND SUPPORT SERVICES; AND MISCELLANEOUS**
6 **BUSINESS ACTIVITIES.**

7 (a) The base gross receipts tax rate provided by this Section is applicable to the business
8 activities of private education and health services, and administrative and support services. This rate
9 also applies to all business activities not otherwise exempt and not elsewhere subjected to a gross
10 receipts tax rate or an administrative office tax by this Article. Commencing on the operative date of
11 the Gross Receipts Tax Ordinance, the Controller shall compute the tax rate in accordance with
12 Section 959, but the base tax rate provided by this Section is:

13 0.525% (e.g., \$5.25 per \$1,000) for gross receipts between \$0 and \$1,000,000

14 0.550% (e.g., \$5.50 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

15 0.600% (e.g., \$6 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

16 0.650% (e.g., \$6.50 per \$1,000) for gross receipts over \$25,000,000

17 (b) Private education and health services include the activity by persons other than
18 governmental agencies of providing instruction and training in any subject, or of providing health care
19 or social assistance for individuals; it includes business activity described in NAICS codes 61 and 62.

20 (c) Administrative and support services includes the activity of performing routine support
21 activities for the day-to-day business activities of others; it includes business activity described in
22 NAICS code 56.

23 (d) The amount of gross receipts from all business activities described in this Section subject to
24 the gross receipts tax shall be determined under Section 956.2.

1 **SEC. 953.5. GROSS RECEIPTS TAX APPLICABLE TO CONSTRUCTION.**

2 (a) The base gross receipts tax rate provided by this Section is applicable to the business
3 activity of construction. Commencing on the operative date of the Gross Receipts Tax Ordinance, the
4 Controller shall compute the tax rate in accordance with Section 959, but the base tax rate provided by
5 this Section is:

6 0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000

7 0.350% (e.g., \$3.50 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

8 0.400% (e.g., \$4 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

9 0.450% (e.g., \$4.50 per \$1,000) for gross receipts over \$25,000,000

10 (b) Construction includes the activity of preparing sites for, subdividing land for, or working
11 on, buildings or engineering projects (including highways and utility systems); it includes business
12 activity described in NAICS code 23.

13 (c) The amount of gross receipts from construction subject to the gross receipts tax shall be
14 one-half of the amount determined under Section 956.1 plus one-half of the amount determined under
15 Section 956.2. The amount of gross receipts so determined shall then be reduced by any amounts
16 which were included in a person's gross receipts within the City pursuant to Section 956.1, and which
17 that person paid to a subcontractor possessing a valid business registration certificate with the City
18 during the tax year. There shall be no reduction for any other costs, including without limitation costs
19 for materials, fees, equipment, or other services. In order to claim such a reduction, a person must
20 maintain an itemized schedule of payments to subcontractors and information sufficient to enable the
21 Tax Collector to verify that the subcontractor possessed a valid business registration certificate with
22 the City.

23
24 **SEC. 953.6. GROSS RECEIPTS TAX APPLICABLE TO FINANCIAL SERVICES; INSURANCE;**
25 **AND PROFESSIONAL, SCIENTIFIC AND TECHNICAL SERVICES.**

1 (a) The base gross receipts tax rate provided by this Section is applicable to the business
2 activities of financial services; insurance; and professional, scientific and technical services.
3 Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller shall compute
4 the tax rate in accordance with Section 959, but the base tax rate provided by this Section is:

5 0.400% (e.g., \$4 per \$1,000) for gross receipts between \$0 and \$1,000,000

6 0.460% (e.g., \$4.60 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

7 0.510% (e.g., \$5.10 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

8 0.560% (e.g., \$5.60 per \$1,000) for gross receipts over \$25,000,000

9 (b) Financial services includes the activities of engaging in or facilitating financial
10 transactions; it includes business activities described in NAICS codes 521, 522 and 523.

11 (c) Insurance includes the activities of facilitating or supporting the pooling of risk by
12 underwriting insurance and annuities; the activities covered by this Section include those of persons
13 not exempt from the gross receipts tax based on business activities described in NAICS code 524.

14 (d) Professional, scientific and technical services includes the activity of providing for others,
15 specialized professional, scientific, or technical services that require a high degree of expertise and
16 training; it includes business activity described in NAICS code 54.

17 (e) The amount of gross receipts from the activities described in this Section subject to the
18 gross receipts tax shall be the amount determined under Section 956.2.

19
20 **SEC. 953.7. GROSS RECEIPTS TAX APPLICABLE TO REAL ESTATE AND RENTAL AND**
21 **LEASING SERVICES.**

22 (a) The base gross receipts tax rate provided by this Section is applicable to the business
23 activities of real estate and rental and leasing services. Commencing on the operative date of the
24 Gross Receipts Tax Ordinance, the Controller shall compute the tax rate in accordance with
25 Section 959, but the base tax rate provided by this Section is:

1 0.285% (e.g., \$2.85 per \$1,000) for gross receipts between \$0 and \$1,000,000

2 0.285% (e.g., \$2.85 per \$1,000) for gross receipts between \$1,000,001 and \$5,000,000

3 0.300% (e.g., \$3.00 per \$1,000) for gross receipts between \$5,000,001 and \$25,000,000

4 0.300% (e.g., \$3.00 per \$1,000) for gross receipts over \$25,000,000

5 (b) Real estate and rental and leasing services includes the activities of renting, leasing, or
6 otherwise allowing the use of tangible or intangible assets, and the activity of providing related
7 services; it includes business activity described in NAICS code 53.

8 (c) The amount of gross receipts from real estate and rental and leasing services subject to the
9 gross receipts tax shall be the total amount of gross receipts derived from or related to properties
10 located or used within the City. Gross receipts shall not include amounts derived from or related to
11 properties located or used outside the City.

12
13 **SEC. 953.8. TAX ON ADMINISTRATIVE OFFICE BUSINESS ACTIVITIES.**

14 (a) Except as provided in this Section, notwithstanding any other provision of this Article and
15 in lieu of the other taxes provided by this Article and Article 12-A for any person or combined group,
16 commencing on the Operative Date of the Gross Receipts' Tax Ordinance, every person engaging in
17 business within the City as an administrative office, as defined below, shall pay an annual
18 administrative office tax measured by its total payroll expense that is attributable to the City. If a
19 person is a member of a combined group, then its tax shall be measured by the total payroll expense of
20 the combined group attributable to the City. Such combined group shall pay only the administrative
21 office tax. The administrative office tax rate for each tax year is 1.400 percent.

22 (b) "Engaging in business within the City as an administrative office" means that:

23 (1) a person is engaging in business within the City during the tax year and over
24 50 percent of the total combined payroll expense within the City of that person and its related entities

1 for the preceding tax year was associated with providing administrative or management services
2 exclusively to that person or related entities;

3 (2) the total combined number of employees of that person and its related entities within
4 the United States as of the last day of the preceding tax year exceeded 1,000; and

5 (3) the total combined gross receipts of that person and its related entities reported on
6 United States federal income tax return(s) for the preceding tax year exceeded \$1,000,000,000.

7 (c) For purposes of subsection (b) only, a related entity shall include any person who could be
8 included in the same combined report under California Revenue and Taxation Code Section 25102 but
9 for the existence of a water's edge election under Section 25110 of that Code.

10 (d) "Administrative or management services" comprises internal support services provided on
11 an enterprise-wide basis, such as executive office oversight, company business strategy, recordkeeping,
12 risk management, personnel administration, legal, accounting, market research and analysis, and
13 training services; it does not include sales personnel or personnel actively engaged in marketing,
14 research and development, direct customer service, and product support services. The Tax Collector is
15 authorized to classify in its reasonable discretion which personnel employed by any person provide
16 administrative or management services.

17 (e) A person provides administrative office services exclusively for itself or a related entity only
18 if the final recipient of those services is at a location where that person or a related entity conducts
19 business activities.

20 (f) "Payroll expense" for purposes of this Section shall have the meaning given to that term by
21 Sections 902.1 et seq. of Article 12-A, except that Section 902.1(b) of Article 12-A shall not apply for
22 purposes of determining whether a person is engaging in business within the City as an administrative
23 office. Section 902.1(b) shall apply for all other purposes under this Section. The portion of the
24 payroll expense of a person or combined group that is attributable to the City shall be determined as
25 set forth in Section 904 of Article 12-A.

1 (g) In addition to the administrative office tax provided in subsection (a), any person engaging
2 in business within the City as an administrative office exclusively for itself or a related entity shall
3 apply for a registration certificate and pay a registration fee, as provided in Article 12.

4 (h) Except as provided in this Section, the provisions of Article 6 and Article 12 apply to the
5 administrative office tax. In particular, and without limiting the applicability of the balance of Article
6 6, the provisions of Sections 6.9-1 through 6.9-3, inclusive, of Article 6, regarding due dates, returns
7 and prepayments, apply to the administrative office tax.

8
9 **SEC. 953.9. PERSONS OR COMBINED GROUPS ENGAGED IN MULTIPLE BUSINESS**
10 **ACTIVITIES.**

11 If a person, or a combined group as described in Section 956.3, engages in business activities
12 described in more than one of Sections 953.1 through 953.7, inclusive, of this Article, the rate or rates
13 of gross receipts tax to be applied to that person or group, and the method for determining gross
14 receipts in the City, shall be determined as follows:

15 (a) If more than 80 percent of its gross receipts, determined in accordance with Section 956,
16 are derived from business activities described in only one of Sections 953.1 through 953.7, inclusive,
17 then the rules of that applicable Section apply to all of its gross receipts derived from all business
18 activities.

19 (b) If its business activities in the City are described in more than one of Sections 953.1
20 through 953.7, inclusive, and subsection (a) of this Section does not apply, then such person or
21 combined group shall separately compute the gross receipts tax for each set of business activities as
22 provided in the Section applicable to that particular set of business activities, modified as follows:

23 (1) if the set of business activities described in any of Sections 953.1 through 953.7,
24 inclusive, generates less than 20 percent of the total gross receipts of the person or group, then the
25 receipts and payroll of any such set of activities may be combined for all purposes related to computing

1 the gross receipts tax with whichever set of that person's or group's activities are taxed at the highest
2 rate;

3 (2) the small business exemption provided in Section 954.1 shall apply only if the sum of
4 receipts within the City from all sets of business activities does not exceed \$1,000,000 in total;

5 (3) the progressive rates described in Sections 953.1 through 953.7 apply on an
6 aggregate basis for businesses with multiple sets of activities;

7 (4) the applicable rate for each set of business activities shall be determined in
8 numbered order of the Sections describing each set of business activities; i.e., the gross receipts and tax
9 for business activities described in Section 953.1 should be determined first, Section 953.2 second, and
10 so on;

11 (5) the rate(s) applicable to any set of activities after the first shall be determined by
12 adding together the gross receipts determined for all previous sets of activities and applying the rate
13 scale commencing with the total gross receipts so determined; and

14 (6) the gross receipts tax liability for the person or combined group shall be the sum of
15 the liabilities for each set of business activities.

16
17 **SEC. 954. EXEMPTIONS AND EXCLUSIONS.**

18 (a) Except as provided in subsection (b) of this Section, an organization that is exempt from
19 income taxation by Chapter 4 (commencing with Section 23701) of Part 11 of Division 2 of the Revenue
20 and Taxation Code or Subchapter F (commencing with Section 501) of Chapter 1 of Subtitle A of the
21 Internal Revenue Code of 1986, as amended, as qualified by Sections 502, 503, 504 and 508 of the
22 Internal Revenue Code of 1986, as amended, shall be exempt from taxation under this Article, only so
23 long as those exemptions continue to exist under state or federal law.

24 (b) An organization otherwise exempt from income taxation under subsection (a) that is
25 directly engaged within the City in an unrelated trade or business within the meaning of Section 513(a)

1 of the Internal Revenue Code of 1986, as amended, and has, from its own operations, unrelated
2 business taxable income within the meaning of Section 512(a)(1) of the Internal Revenue Code of 1986,
3 as amended, shall pay the gross receipts tax on its gross receipts from its unrelated trade or business
4 activities that are attributable to the City. If it is impracticable, unreasonable or improper to allocate
5 such organization's gross receipts as aforesaid either because of the particular nature of the
6 organization's unrelated trade or business or for any other reason, then the amount of gross receipts
7 reasonably attributable to the organization's unrelated trade or business in the City shall be
8 determined on the basis of all of the relevant facts and circumstances of the particular case, in
9 accordance with any rulings or regulations issued or promulgated by the Tax Collector for this
10 purpose.

11 (c) Gross receipts as defined in Section 952.3 shall not include receipts from business activities
12 if, and only so long as and to the extent that, the City is prohibited from taxing such receipts under the
13 Constitution or laws of the United States or under the Constitution or laws of the State of California.

14 (d) Rent Controlled Buildings Exclusion. A person subject to the tax may exclude from gross
15 receipts in any tax year 50 percent of the total amount received from the rental of real property to
16 tenants in occupancy at any location in the City, which is subject to limits on rent increases pursuant to
17 the Residential Rent Stabilization and Arbitration Ordinance, San Francisco Administrative Code,
18 Chapter 37, Section 37.1 et seq.

19 (e) Exclusion of Certain Sales of Real Property. Gross receipts as defined in Section 952.3
20 shall not include receipts from any sales of real property with respect to which the Real Property
21 Transfer Tax imposed by Article 12-C has been paid to the City.

22 (f) For only so long as and to the extent that the City is prohibited from imposing the tax under
23 this Article, the following persons shall be exempt from the gross receipts tax:

24 (1) Banks and financial corporations exempt from local taxation under Article XIII,
25 Section 27 of the California Constitution and Revenue and Taxation Code Section 23182;

1 (2) Insurance companies exempt from local taxation under Article XIII, Section 28 of
2 the California Constitution;

3 (3) Persons engaging in business as a for-hire motor carrier of property under Revenue
4 and Taxation Code Section 7233;

5 (4) Persons engaging in intercity transportation as a household goods carrier under
6 Public Utilities Code Section 5327;

7 (5) Charter-party carriers operating limousines that are neither domiciled nor maintain
8 a business office within the City under Public Utilities Code Section 5371.4; and

9 (6) Any person upon whom the City is prohibited under the Constitution or laws of the
10 State of California from imposing the gross receipts tax.

11 (g) To the extent that any taxpayer has paid a substantially similar tax to any other taxing
12 jurisdiction on any gross receipts attributed to the City and taxed under this Article, the tax paid to
13 such taxing jurisdiction shall be credited against the tax due under this Article; in no event shall this
14 credit reduce the taxpayer's liability to less than zero.

15
16 **SEC. 954.1. SMALL BUSINESS EXEMPTION.**

17 (a) Notwithstanding any other provision of this Article, a "small business enterprise," as
18 hereinafter defined for purposes of this Article 12-A-1, shall be exempt from payment of the gross
19 receipts tax, nevertheless, a small business enterprise shall pay the annual registration fee pursuant to
20 Section 855 of Article 12.

21 (b) For purposes of this Article 12-A-1, the term "small business enterprise" shall mean and
22 include any person or combined group, except for a lessor of residential real estate:

23 (1) Whose gross receipts within the City for the preceding tax year did not exceed
24 \$1,000,000, adjusted annually in accordance with the increase in the Consumer Price Index: All
25 Urban Consumers for the San Francisco/Oakland/San Jose Area for All Items as reported by the

1 United States Bureau of Labor Statistics, or any successor to that index, as of December 31st of the
2 preceding year, beginning with December 31, 2014; and

3 (2) Who filed a tax return by the last day of February for the preceding tax year, if that
4 person or group had gross receipts in the City of over \$500,000. If a person is required to file a tax
5 return under this Section, and fails to file a return by that date, the taxpayer shall be subject to a
6 penalty as specified in subsection (c).

7 (c) In lieu of the penalty specified in Section 6.17-3 of Article 6 for failing to file a return, any
8 person who otherwise qualifies for the small business exemption set forth in this Section, and who had
9 gross receipts in the City of over \$500,000, who fails to file a return by the last date of February shall
10 pay a penalty as follows:

11 (1) The penalty for the first month, or fraction thereof, that the return is delinquent,
12 shall be 5 percent of the amount of the tax liability, calculated without regard to the small business
13 exemption in this Section. The penalty shall increase by an additional 5 percent each month, or
14 fraction thereof, that the return is delinquent, up to a maximum of 20 percent of the tax liability. Any
15 penalties remaining unpaid for a period of 90 days or more shall be subject to an additional penalty of
16 20 percent of the amount of the tax liability excluding penalties and interest.

17 (2) Penalties are due and payable when assessed. Unpaid penalties, interest and fees
18 shall accrue interest at the rate of 1 percent per month, or fraction thereof, from the date that they are
19 assessed through the date of payment. The total amount of the penalties, interest and fees shall not
20 exceed the amount of the person's gross receipts tax liability for the period but for the small business
21 exemption.

22 (d) The Tax Collector may, at his or her discretion, reduce the penalty set forth in
23 subsection (c) to not less than \$100 upon a showing that the late filing of the return was due to
24 reasonable cause and not due to willful neglect.

1 (e) For purposes of this Article 12-A-1, and notwithstanding any other provision of this Section,
2 a lessor of residential real estate is a "small business enterprise" if and only if the lessor leases fewer
3 than 4 units in any individual building. "Residential real estate" means real property where the
4 primary use of or right to use the property is for the purpose of dwelling, sleeping or lodging other than
5 as part of the business activity of accommodations. For purposes of this Article 12-A-1, Article 12-A,
6 and Article 12, a lessor of residential real estate is treated as a separate person with respect to each
7 individual building in which it leases residential real estate units, notwithstanding Section 6.2-15 of
8 Article 6, or Section 956.3 of this Article. The provisions of this subsection apply only to leasing
9 residential real estate units within a building, and not to any business activity related to other space,
10 either within the same building or other buildings, which is not residential real estate. The Tax
11 Collector is authorized to determine what constitutes a separate building and the number of units in a
12 building.

13
14 **SEC. 955. PERSONS DERIVING NO GROSS RECEIPTS FROM BUSINESS ACTIVITIES**
15 **OUTSIDE THE CITY.**

16 Notwithstanding any other provision of this Article, any person subject to the gross receipts tax
17 who derives non-exempt gross receipts from business activities within the City and derives no gross
18 receipts from business activities outside the City is subject to tax on all non-exempt gross receipts.

19
20 **SEC. 956. ALLOCATION AND APPORTIONMENT FOR ALL PERSONS DERIVING GROSS**
21 **RECEIPTS FROM BUSINESS ACTIVITIES BOTH WITHIN AND OUTSIDE THE CITY.**

22 All persons deriving gross receipts from business activities both within and outside the City
23 shall allocate and/or apportion their gross receipts to the City, using the rules set forth in Section 956.1
24 and 956.2, in the manner directed in Sections 953.1 through 953.7, inclusive, and in Section 953.9 of
25 this Article.

1
2 **SEC. 956.1. ALLOCATION OF RECEIPTS FROM REAL, PERSONAL, TANGIBLE AND**
3 **INTANGIBLE PROPERTY.**

4 (a) For all persons required to determine an amount of gross receipts pursuant to this Section,
5 that amount shall be all non-exempt gross receipts within the City as determined hereunder.

6 (b) Gross receipts from the sale, lease, rental or licensing of real property are in the City if the
7 real property is located in the City.

8 (c) Gross receipts from sales of tangible personal property are in the City if the property is
9 delivered or shipped to a purchaser within the City regardless of the f.o.b. point or other conditions of
10 the sale.

11 (d) Gross receipts from the rental, lease or licensing of tangible personal property are in the
12 City if the property is located in the City.

13 (e) Gross receipts from services are in the City to the extent the purchaser of the services
14 received the benefit of the services in the City.

15 (f) Gross receipts from intangible property are in the City to the extent the property is used in
16 the City. In the case of financial instruments, sales are in the City if the customer is located in the City.

17
18 **SEC. 956.2. APPORTIONMENT OF RECEIPTS BASED ON PAYROLL.**

19 (a) For all persons required to determine an amount of gross receipts pursuant to this Section,
20 that amount shall be all non-exempt combined gross receipts of the person multiplied by a fraction, the
21 numerator of which is payroll in the City and the denominator of which is combined payroll.

22 (b) Combined gross receipts are the total worldwide gross receipts of the person and all
23 related entities to the person, unless the election provided for in California Revenue and Taxation Code
24 Section 25110 is in effect for the person, in which case combined gross receipts shall be computed
25 consistently with the water's edge election, as set forth therein.

1 (c) Combined payroll is the total worldwide compensation paid by the person and all related
2 entities to the person, unless the election provided for in California Revenue and Taxation Code
3 Section 25110 is in effect for the person, in which case combined payroll shall be computed consistently
4 with the water's edge election, as set forth therein. A person who has no combined payroll in a tax year
5 shall have no gross receipts under this Section for that tax year.

6 (d) Payroll in the City is the total amount paid for compensation in the City by the person and
7 by all related entities to the person.

8 (e) Compensation paid in the City shall be determined as set forth in Section 904 of
9 Article 12-A.

10 (f) "Compensation" means wages, salaries, commissions and any other form of remuneration
11 paid to employees for services. In the case of any person who has no employees, compensation shall
12 also include all taxable income for federal income tax purposes of the owners or proprietors of such
13 person who are individuals. Those owners or proprietors shall be treated as individuals to whom
14 compensation is paid for purposes of subsection (e).

15 (g) The apportionment provided by this Section shall not include in either the numerator or the
16 denominator any payroll of persons exempt from tax under subsections (a), (b), or (f) of Section 954.

17
18 **SEC. 956.3. COMBINED RETURNS.**

19 A person engaging in business within the City must file gross receipts tax returns as provided in
20 Article 6. Those returns must be filed on a combined basis with all of that person's related entities.
21 That person, and all of that person's related entities, constitute a combined group. Every combined
22 group must file a single return; the combined group may choose a single person to file the return on its
23 behalf. Each person within the combined group engaging in business in the City must provide a power
24 of attorney to the person filing the return, authorizing the person filing the return to file said return and
25 to act on behalf of each person with respect to payments, refunds, audits, resolutions, and any other

1 items related to the tax liability reflected in the return. The power of attorney shall be substantially in
2 a form to be promulgated by the Tax Collector. Each return filed by a combined group constitutes a
3 combined return under this Article and Article 6. The person filing any combined return shall pay the
4 tax liability reflected on the return and any liability determined on audit at the time and in the manner
5 set forth for returns and liabilities in Article 6.

6 **SEC. 957. TAX COLLECTOR AUTHORIZED TO DETERMINE GROSS RECEIPTS.**

7 The Tax Collector may, in his or her reasonable discretion, independently establish a person's
8 gross receipts within the City and establish or reallocate gross receipts among related entities so as to
9 fairly reflect the gross receipts within the City of all persons. This authority extends to determining
10 whether any amount excluded from gross receipts by virtue of Section 952.3(f) is in whole or in part
11 compensation or payment for services and thus included in gross receipts.

12
13 **SEC. 958. ADMINISTRATION OF THE GROSS RECEIPTS TAX ORDINANCE.**

14 Except as otherwise provided under this Article, the Gross Receipts Tax Ordinance shall be
15 administered pursuant to Article 6 of the San Francisco Business and Tax Regulations Code.

16
17 **SEC. 959. RATE OF GROSS RECEIPTS TAX: CONTROLLER COMPUTATION.**

18 (a) Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller
19 shall compute the rate of gross receipts tax for Sections 953.1 through 953.7 in accordance with
20 subsection (b) of this Section. The Controller shall certify and publish such rates on or before
21 September 1 of each year.

22 (b) Gross Receipts Tax Computation. The Controller shall compute the gross receipts tax rates
23 for each tax year by multiplying each base rate in Sections 953.1 through 953.7 by the "Gross Receipts
24 Tax Rate Adjustment Factor," which shall be determined according to the following table and formulas,
25 but no gross receipts tax rate shall exceed the base rates provided by Sections 953.1 through 953.7.

Where: "EXP_{year}" is the "Excess Payroll Expense Tax Revenue Factor," a percentage that reduces the gross receipts tax rate adjustment factor for a year in which the payroll expense tax rate determined under Section 903.1 of Article 12-A becomes zero, and which adjusts for excess payroll expense tax revenue collected for that tax year. The Controller shall compute EXP_{year} according to the following table and formulas:

(1) In any year in which PAYRATE_{year} is greater than zero, where PAYRATE_{year} is determined under Section 903.1 of Article 12-A, EXP_{year} is zero.

(2) In the first year in which PAYRATE_{year} is zero, where PAYRATE_{year} is determined under Section 903.1 of Article 12-A, EXP_{year} shall be computed according to the following table and formulas. In subsequent years, GADJ_{year} shall be the same value it was in the prior year:

Where: PADJ_{year}, PAYTAX_{year}, and GRTAX_{year} are determined under Section 903.1 of Article 12-A.

(c) Notwithstanding any other provision of this Article, in any year in which the payroll expense tax rate determined under Section 903.1 of Article 12-A is zero, the gross receipts tax rates for that year and all future years shall be as the Controller computed for that year, except that for tax year 2021 and all future years, the rate under Section 953.7(a), for gross receipts over \$25,000,000 only, shall be the sum of the rate established under this Section 959(c) and 0.025%. In no event shall the rate established under Section 953.7(a) by the preceding sentence, for gross receipts over \$25,000,000, exceed 0.325%. The Controller shall certify and publish such rates by September 1 of that year.

(d) Notwithstanding any other provision of this Article, the gross receipts tax rates for 2019 and all future years shall be the rates in effect in tax year 2018, except that for tax year 2021 and all future years, the rate under Section 953.7(a), for gross receipts over \$25,000,000 only, shall be the sum of the rate established under this Section 959(c) and 0.025%. In no event shall the rate established under Section 953.7(a) by the preceding sentence, for gross receipts over \$25,000,000, exceed 0.325%. The Controller shall certify and publish such rates on or before September 1, 2019, at which time the Controller's duty to compute, certify and publish the payroll expense tax rate shall cease.

SEC. 960. THE "PAYROLL EXPENSE TAX EXCLUSION" CREDIT.

(a) "Payroll Expense Tax Exclusion Credit" means the dollar amount by which a person would have been able to reduce its payroll expense tax liability pursuant to the Enterprise Zone Tax Credit under Section 906A of Article 12-A, the Biotechnology Exclusion under Section 906.1 of Article 12-A, and/or the Clean Technology Business Exclusion under Section 906.2 of Article 12-A, as if the payroll expense tax were in full force and effect and calculated at a rate of 1½ percent.

1 (b) "Combined Business Tax Liability" means the sum of the gross receipts tax and the payroll
2 expense tax a person owes for a tax year.

3 (c) For so long as a particular payroll expense tax exclusion listed under subsection (a) is in
4 effect, without regard to whether the payroll expense tax is otherwise in effect, a person may credit
5 against its combined business tax liability for a tax year the amount of a particular payroll expense tax
6 exclusion credit to which it would be entitled under the payroll expense tax; however, in no event shall
7 such credit reduce a person's combined business tax liability to less than zero. Any person who claims
8 the credit under this Section must meet all of the eligibility requirements of the payroll expense tax
9 exclusion(s) it claims. The credit may be claimed against the tax liability only of the person who
10 qualified for the payroll expense tax exclusion and not against any liability of related entities or other
11 members of that person's combined group.

13 **SEC. 961. CENTRAL MARKET STREET LIMIT.**

14 (a) The "Central Market Street Limit" means a person's payroll expense tax liability for a tax
15 year as determined under the Central Market Street and Tenderloin Area Payroll Expense Tax
16 Exclusion under Section 906.3 of Article 12-A, calculated at a rate of 1½ percent.

17 (b) "Combined Business Tax Liability" means the sum of the gross receipts tax and the payroll
18 expense tax a person owes that is attributable to location(s) in the Central Market Street and
19 Tenderloin Area as defined in Section 906.3(b) of Article 12-A for a tax year under the rates
20 established for that year.

21 (c) For so long as the Central Market Street and Tenderloin Area Payroll Expense Tax
22 Exclusion is in effect, without regard to whether the payroll expense tax is otherwise in effect, a person
23 shall owe the lesser of its combined business tax liability or the amount of its Central Market Street
24 limit. Any person who claims the Central Market Street and Tenderloin Area Payroll Expense Tax
25 Exclusion must meet all of the eligibility requirements of that exclusion.

SEC. 962. AMENDMENT OF ORDINANCE.

The Board of Supervisors may amend or repeal Article 12-A-1 of the Business and Tax Regulations Code without a vote of the people except as limited by Article XIII C of the California Constitution.

SEC. 963. EFFECT OF STATE AND FEDERAL AUTHORIZATION.

To the extent that the City's authorization to impose or collect any tax imposed under this Article 12-A-1 is expanded or limited as a result of changes in state or federal law, no amendment or modification of this Article 12-A-1 shall be required to conform the taxes to those changes, and the taxes are hereby imposed and the Tax Collector shall collect them to the full extent of the City's authorization up to the full amount and rate of the taxes imposed under this Article 12-A-1.

SEC. 964. SEVERABILITY.

Except as provided in Section 965(b) below, if any section, sentence, clause, phrase, or portion of Article 12-A-1 is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining sections, sentences, clauses, phrases, or portions of this Article shall nonetheless remain in full force and effect. The people of the City and County of San Francisco hereby declare that, except as provided in Section 965(b), they would have adopted each section, sentence, clause, phrase, or portion of this Article, irrespective of the fact that any one or more sections, sentences, clauses, phrases, or portions of this Article be declared invalid or unenforceable and, to that end, the provisions of this Article are severable.

SEC. 965. SAVINGS CLAUSE.

1 (a) No section, clause, part or provision of this Article shall be construed as requiring the
2 payment of any tax that would be in violation of the Constitution or laws of the United States or of the
3 Constitution or laws of the State of California. Except as provided in subsection (b) of this Section, if
4 any section, clause, part or provision of this Article, or the application thereof to any person or
5 circumstance, is held invalid or unconstitutional, the remainder of this Article, including the
6 application of such part or provision to other persons or circumstances, shall not be affected thereby
7 and shall continue in full force and effect. To this end, the provisions of this Article are severable.

8 (b) If the imposition of the gross receipts tax in Section 953, or any portion of the rate
9 computation under Section 959, of this Article is held invalid or unconstitutional in a final court
10 determination, the remainder of this Article shall be null and void and of no force and effect. For any
11 tax year for which this Article is invalidated pursuant to this Section, the payroll expense tax provided
12 by Article 12-A may be assessed against any person engaging in business in the City during that tax
13 year as if this Ordinance had not been passed, except that such assessment may be made and collected
14 notwithstanding any statute of limitations provided by Article 6.

16 Section 4. Operative Date.

17 Except for Section 5, this Ordinance shall become operative the first day of the first
18 calendar quarter commencing after December 31, 2013. Section 5 shall become operative on
19 the effective date of this Ordinance.

23 registration certificate for each location within the City where the person engages in business.

24 (j) The person may register up to 15 fictitious business names (sometimes abbreviated DBA,
25 dba or d/b/a) without an additional charge. The Tax Collector shall charge a fee of \$25, in addition to

1 the registration fee, for each fictitious business name under which the business or operation is
2 registered to conduct business in the City in addition to the first 15 fictitious business names registered.

3 (k) In addition to all other civil penalties provided for by law, the Tax Collector may charge
4 any person who fails to register in a timely manner a fictitious business name or a location within the
5 City where the person engages in business, an administrative penalty of \$500 per fictitious business
6 name or business location that the person fails to register.

4 (b) Commencing on the operative date of the Gross Receipts Tax Ordinance, the rate of the
5 payroll expense tax shall be computed by the Controller in accordance with subsections (c) and (d).
6 The Controller shall certify and publish such rate on or before September 1 of each year.

7 (c) Commencing on the operative date of the Gross Receipts Tax Ordinance:

8 (1) For any tax year in which the payroll expense tax rate, computed in accordance
9 with subsection (d), is less than zero, then the payroll expense tax rate for that year and all subsequent
10 years shall be zero. The Controller shall certify and publish such rate on or before September 1 of that

12 (2) Notwithstanding any other provision of this Article or Article 12-A-1, the payroll
13 expense tax rate for 2019 and all future years shall be the rate in effect in tax year 2018. The
14 Controller shall certify and publish such rate on or before September 1, 2019, at which time the
15 Controller's duty to compute, certify and publish the payroll expense tax rate shall cease.

16 (3) Notwithstanding any other provision of this Article or Article 12-A-1, in no event

23 amount less than zero. For each fiscal year, the Controller shall determine whether the City
24 and County of San Francisco has surplus Business Tax revenue. The Controller's
25 determination whether the City and County of San Francisco has surplus Business Tax

1 revenue shall be made on or before the first business day of September following the close of
2 such fiscal year; provided, however, that for purposes of the 1997/1998 fiscal year, the
3 Controller may make his or her determination on or before December 31, 1998. The Controller
4 shall notify the Tax Collector of his or her determination.

5 (b) Amount of Credit. For purposes of this Section, the amount of the tax credit for any
6 taxable year shall be \$500.00; provided, however, that in no event shall the tax credit
7 allowable pursuant to this Section reduce a taxpayer's liability for such tax to an amount less

9 (c) Definitions. The following definitions shall apply to the terms used in this Section.

10 (1) For any fiscal year of the City and County of San Francisco, the City and
11 County of San Francisco shall be deemed to have "surplus Business Tax revenue" if and only
12 if the actual Business Tax revenue for such fiscal year exceeds the anticipated Business Tax
13 revenue for such fiscal year.

14 (2) For any fiscal year of the City and County of San Francisco, the "actual
15 Business Tax revenue" means the aggregate amount of tax revenue collected pursuant to
16 Article 12-A (Payroll Expense Tax Ordinance) and Article 12-B (Business Tax Ordinance) of
17 Part III of the San Francisco Municipal Code, less the amount of such revenue for such year
18 allocable solely to tax rate increases in such year.

19 (3) For any fiscal year of the City and County of San Francisco, the "anticipated
20 Business Tax revenue" is an amount equal to the product of (i) the actual Business Tax
21 revenue for the fiscal year immediately preceding such fiscal year, multiplied by
22 (ii) 107.5 percent.

23 (d) Effective Date. The tax credit provided by this Section shall be allowable in taxable
24 years ending after 1997 and shall expire by operation of law on December 31, 2018. The City

1 Attorney shall cause it to be removed from future editions of the Business and Tax Regulations Code
2 after that date.

4 **SEC. 909. AMENDMENT OF ORDINANCE.**

Article 12-A-1 (Gross Receipts Tax Ordinance), and the registration fee imposed by Article 12
(Business Registration Ordinance) shall apply to any person engaging in business within the
City unless exempted therefrom under such Articles. A person is "engaging in business within
the City," within the meaning of this Article, if that person meets one or more of the following
conditions:

~~(1a)~~ The person maintains a fixed place of business within the City; or

~~(2b)~~ An employee, representative or agent of the person maintains a fixed place
of business within the City for the benefit or partial benefit of the person; or

~~(3c)~~ The person or one or more of the person's employees, representatives or
agents owns, rents, leases, or hires real or personal property within the City for business
purposes for the benefit or partial benefit of the person; or

~~(4d)~~ The person or one or more of the person's employees, representatives or
agents regularly maintains a stock of tangible personal property within the City, for sale in the
ordinary course of the person's business; or

~~(5e)~~ The person or one or more of the person's employees, representatives or
agents employs or loans capital on property within the City for the benefit or partial benefit of
the person; or

~~(6f)~~ The person or one or more of the person's employees, representatives or
agents solicits business within the City for all or part of any seven days during a tax year; or

~~(7g)~~ The person or one or more of the person's employees, representatives or
agents performs work or renders services within the City for all or part of any seven days
during a tax year; or

1 (~~8h~~) The person or one or more of the person's employees, representatives or
2 agents utilizes the streets within the City in connection with the operation of motor vehicles for
3 business purposes for all or part of any seven days during a tax year; or

5 agents exercises corporate or franchise powers within the City for the benefit or partial benefit

7 file a return for the subject period on a form provided by the Tax Collector, regardless of

18 (1) With respect to each tax year, the Tax Collector may exempt from the

20 Tax Ordinance, computed without regard to the small business exemption set forth in Section
21 905-A of Article 12-A, is less than the Minimum Filing Amount for such tax year. For purposes
22 of this Section, the Minimum Filing Amount shall be an amount of tax liability, computed
23 without regard to such small business exemption, between zero and \$2,250. The Tax
24 Collector shall specify the Minimum Filing Amount prior to the beginning of each tax year. If

4 Installments. A person's first, second and third quarterly installment payments of payroll expense tax
5 for any tax year shall be computed by using:

6 1. 104 percent of ~~the~~ the person's taxable payroll expense (as
7 defined in Section 902.1 of ~~under~~ Article 12-A) for the preceding tax year, each quarter; and

8 2. The rate of tax applicable to the tax year in which the
9 first, second and third quarterly installments are due. The fourth installment shall be reported and
10 paid on or before the last day of February of the following year. The fourth quarterly installment shall
11 be in an amount equal to the person's total Payroll Expense Tax liability for the subject tax year, less
12 the amount of the first, second and third quarterly installments and other tax prepayments, if any,
13 actually paid.

The fourth quarterly installment shall be in an amount equal to the person's total payroll expense tax liability for the subject tax year, less the amount of the first, second and third quarterly installments and other tax payments, if any, actually paid. A person's total payroll expense tax liability shall be computed using the rate for the subject tax year computed, certified, and published by the Controller under Section 903.1 of Article 12-A or as otherwise provided in this Article.

(iii) Gross Receipts Tax Installments. A person's first, second, and third quarterly installments of gross receipts tax for any tax year shall be computed by using:

1. The person's taxable gross receipts (as defined under Article 12-A-1) for each quarter; and

2. The rate of tax applicable to the tax year in which the first, second and third quarterly installments are due.

3. Notwithstanding the foregoing, and except for taxpayers under Section 953.8 of Article 12-A-1, for tax years commencing after December 31, 2013, the first, second and third quarterly installments shall be computed using the rates applicable to the person's taxable gross receipts under Sections 953.1 through 953.7 of Article 12-A-1, multiplied by the percentages set forth in the following table:

1 The fourth quarterly installment shall be in an amount equal to the person's total gross receipts
2 tax liability for the subject tax year, less the amount of the first, second and third quarterly installments
3 and other tax payments, if any, actually paid. A person's total gross receipts tax liability shall be
4 computed using the rate for the subject tax year computed, certified, and published by the Controller
5 under Section 959 of Article 12-A-1, or as otherwise provided in that Article.

6 (b) Tax Prepayment Penalties. Every person who fails to pay any tax prepayment
7 required under this Section before the relevant delinquency date shall pay a penalty in the
8 amount of 5 percent of the amount of the delinquent tax prepayment per month, or fraction
9 thereof, up to 20 percent in the aggregate, and shall also pay interest on the amount of the
10 delinquent tax prepayment and penalties from the date of delinquency at the rate of 1 percent
11 per month, or fraction thereof, for each month the prepayment is delinquent, until paid.

12 (c) Hotel and Parking Taxes. An operator subject to the Hotel Tax (Article 7) or the
13 Parking Tax (Article 9) shall make monthly remittances in the amount of the actual tax owed.

14 (d) Forms and Adjustments. Tax prepayments required under this Section shall be
15 accompanied by a tax prepayment form prepared by the Tax Collector, but failure of the Tax
16 Collector to furnish the taxpayer with a tax prepayment form shall not relieve the taxpayer
17 from any tax prepayment obligation. The Tax Collector may, in writing, adjust the amount of a
18 tax prepayment if the taxpayer can establish in writing by clear and convincing evidence that
19 the first installment of semi-annual tax prepayments, or first, second or third monthly
20 installment of a quarterly tax prepayment, will amount to more than one-half or one-quarter,
21 respectively, of the person's total tax liability for the tax year in which the installment is due.

23 **SEC. 6.24-1. AMENDMENT OF ORDINANCE.**

24 The Board of Supervisors may amend or repeal Article 6 of the Business and Tax Regulations
25 Code without a vote of the people except as limited by Article XIII C of the California Constitution.

1 Section 8. Effective Date.

2 This measure shall go into effect 10 days after the date the official vote count is
3 declared by the Board of Supervisors.

4
5 Section 9. Severability.

6 Except as provided in Section 11 of this Ordinance, if any section, sentence, clause,
7 phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a
8 court of competent jurisdiction, the remaining sections, sentences, clauses, phrases, or
9 portions of this Ordinance shall nonetheless remain in full force and effect. The people of the
10 City and County of San Francisco hereby declare that, except as provided in Section 11, they
11 would have adopted each section, sentence, clause, phrase, or portion of this Ordinance,
12 irrespective of the fact that any one or more sections, sentences, clauses, phrases, or
13 portions of this Ordinance be declared invalid or unenforceable and, to that end, the
14 provisions of this Ordinance are severable.

15
16 Section 10. Savings Clause.

17 (a) No section, clause, part or provision of this Ordinance shall be construed as
18 requiring the payment of any tax that would be in violation of the Constitution or laws of the
19 United States or of the Constitution or laws of the State of California. Except as provided in
20 Section 965(b) of Article 12-A-1 of this Ordinance, if any section, clause, part or provision of
21 this Ordinance, or the application thereof to any person or circumstances, is held invalid or
22 unconstitutional, the remainder of this Ordinance, including the application of such part or
23 provision to other persons or circumstances, shall not be affected thereby and shall continue
24 in full force and effect. To this end, the provisions of this Ordinance are severable.

1 (b) If the imposition of the gross receipts tax in Section 953 of Article 12-A-1 of this
2 Ordinance is held invalid or unconstitutional in a final court determination, the remainder of
3 this Ordinance shall be null and void and of no force and effect.
4

5 Section 11. In enacting this Ordinance, the voters intend to amend only those words,
6 phrases, paragraphs, subsections, sections, articles, numbers, punctuation, charts, diagrams,
7 or any other constituent part of the Business and Tax Regulations Code that are explicitly
8 shown in this legislation as additions and deletions in accordance with the "Note" that appears
9 under the official title of the legislation.
