7 WHEREAS, The James C. Hormel Gay & Lesbian Center of the San Francisco Public  
8 Library is devoted to the documentation of lesbian and gay history and culture by collecting,  
9 preserving and providing access to material on all aspects of the gay, lesbian, bisexual and  
10 transgender experience; and,

11 WHEREAS, The Center's collections include all formats of published and unpublished  
12 material and the audience includes individuals of all ages and cultures, undergraduate college  
13 students, and researchers seeking information relating to the experience of sexual minorities;

15 WHEREAS, The San Francisco Public Library continually seeks to expand and  
16 improve access to the material collection in the James C. Hormel Gay and Lesbian Center;  
17 and,

18 WHEREAS, The Friends and Foundation of the San Francisco Public Library is a non-  
19 profit organization that seeks to provide outstanding support for the Public Library by providing  
20 resources to accomplish Library goals; and,

21 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,  
22 therefore, be it

23 RESOLVED, That the San Francisco Public Library be authorized to accept and  
24 expend a gift of \$52,000 from the Friends and Foundation of the San Francisco Public Library

1 to purchase books and other materials for the James C. Hormel Gay and Lesbian Center and  
2 to improve access to the Center's materials through focused processing, cataloging, and  
3 archiving of materials in the Center's collection; and be it

4 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
5 indirect costs in the grant budget.


