How are you?

My name is **Edward Siu**, and I represent the **Chinatown Merchants United Association of San Francisco**, which serves merchants in both **Chinatown** and the **Sunset District**.

We are writing to express our deep concern about the growing problem of **illegal street vendors** who are selling stolen goods. Many of these items are taken directly from our local merchants' stores, including grocery stores, fish markets, and fashion shops.

The types of stolen merchandise being sold on the streets include:

- **From grocery and fish markets:** vegetables, canned foods, cooking oil, potatoes, raw chickens, meats, fish, and crabs.
- **From fashion stores:** clothing, gloves, socks, and jackets.

These illegal activities seriously harm our small businesses, undermine public safety, and create an unfair environment for honest merchants.

We respectfully request that the City take **strong enforcement action** to stop the sale of stolen goods on the streets and to **hold illegal vendors accountable**.
