

1 [Grant to establish an enhanced STD Surveillance Network to better understand trends in
2 gonorrhea and other sexually transmitted diseases and develop appropriate interventions in
3 collaboration with other programs throughout the United States.]

5 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
6 **accept and expend retroactively a new grant in the amount of \$80,000 from the Centers**
7 **for Disease Control and Prevention (CDCP), to establish an enhanced STD Surveillance**
8 **Network, to enter into an agreement for the use of these funds, and to add one 1.0 new**
9 **position funded through this grant; for the period of September 30, 2005, to September**
10 **29, 2006.**

11 WHEREAS, SFDPH has applied for and been awarded a new grant in the amount of
12 \$80,000 from CDCP to establish an enhanced STD Surveillance Network; and,

13 WHEREAS, As a condition of receiving the grant funds, CDCP requires the City to
14 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
15 Board of Supervisors in File No. 051912, which is hereby declared to be a part of
16 this resolution as if set forth fully herein; and,

17 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
18 because the Department was not forwarded the State Standard Agreement covering these
19 funds until after September 30, 2005; and,

20 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant
21 funds may be placed automatically on the consent agendas in committee, as they are usually
22 considered to be routine items, and this resolution authorizes the acceptance and expenditure
23 of grant funding; and,

24 WHEREAS, One 1.0 position will be added through this grant; and,

1 WHEREAS, The grant budget includes a provision for indirect costs of \$1,798; now,
2 therefore, be it


3 RESOLVED, That SFDPH is hereby authorized to accept and expend a new grant in
4 the amount of \$80,000 from CDCP; and, be it

5 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
6 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
7 Francisco Administrative Code section 10-170-1; and, be it

8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
9 agreement on behalf of the City; and, be it


10 FURTHER RESOLVED, That the Controller is directed to designate the position funded


