1 [Juvenile Probation and Camp Funding Grant Program.]

3 **Resolution authorizing the Juvenile Probation Department to participate in the State of**
4 **California's Juvenile Probation and Camp Funding Program, to receive funds for direct**
5 **services to eligible children and their families.**

7 WHEREAS, The California Corrections Standards Authority (CSA) administers the
8 Juvenile Probation and Camp Funding (JPCF) Program, which provides funds to support a
9 broad spectrum of county probation services targeting at-risk youth, juvenile offenders, and
10 the families of these youth; and

11 WHEREAS, Through the JPCF Program, the Juvenile Probation Department
12 (Department) is eligible to receive \$2.9 Million in grant funds for Fiscal Year 2008-2009, to use
13 for specified services as allowed under State law; and,

14 WHEREAS, To participate in the JPCF Program and receive the allocated funds, the
15 Department must execute a JPCF Program Agreement with the CSA, a copy of which is on
16 file with the Clerk of the Board of Supervisors in File No. 081448, which is
17 hereby declared to be a part of this resolution as if set forth fully herein; and,

18 WHEREAS, The Department desires to participate in the JPCF Program and use the
19 grant funds to benefit children in San Francisco by providing eligible services to promote
20 increased self-sufficiency, personal responsibility, and family stability for the child; now,
21 therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
23 authorizes the Chief Probation Officer for the Juvenile Probation Department, or a designee,
24 to execute for and on behalf of the City and County of San Francisco the JPCF Program
25 Agreement with the CSA, including any extensions or amendments to that Agreement, and to



1 execute any other agreements, applications, assurances, certificates and other documents
2 and to take any additional actions necessary to obtain JPCF Program funding for Fiscal Year
3 2008-2009; and, be it

4 FURTHER RESOLVED, That the City and County of San Francisco agrees to abide by
5 the statutes governing the JPCF Program as well as the terms and conditions of the
6 Agreement as set forth by the CSA, including the retention of financial records substantiating
7 claimed expenditures and the submission of Semi-Annual Progress Reports.


