11 language in the City Charter; now, therefore, be it

12 MOVED, That the Board of Supervisors of the City and County of San Francisco
13 hereby amends the Rules of Order of the Board to delete Rule 2.23, as follows:

14 ((**2.23 BONDING REQUIREMENTS.** The Board shall annually review the bonding
15 requirements for public officials as required by Charter Section 2.112. The Clerk of the Board
16 shall annually refer to the Finance Committee legislation providing for bonding of public
17 officials.))

18 FURTHER MOVED, That the Board of Supervisors of the City and County of San
19 Francisco hereby amends the Rules of Order of the Board to delete Rule 2.27, as follows:

20 ((**2.27 ELECTION FEES.** The Clerk of the Board shall ensure that legislation
21 establishing election fees is submitted to the Board in time for action before the second
22 Monday in December as required by Section 13.109 of the Charter.))


