3 **Resolution approving the boundaries of the City and County of San Francisco**
4 **Enterprise Zone Targeted Employment Area.**

5

6 WHEREAS, On March 20, 1984, the Governor of the State of California signed into law
7 Assembly Bill 40 (Government Code Section 7070 et esq.) "Enterprise Zone Act," creating a
8 State Enterprise Zone Program; and

9 WHEREAS, On September 26, 1996 the Governor of the State of California signed into
10 law Senate Bill 2023 and Assembly Bill 296, effective January 1, 1997, revising the Enterprise
11 Zone Act requiring, among other things, that Enterprise Zones establish "Targeted
12 Employment Areas" to encourage businesses within the Enterprise Zone to hire eligible
13 residents from geographic areas of the city in most need of employment targeting; and

14 WHEREAS, On September 9, 2006, the Governor of the State of California signed into
15 law Assembly Bill 1550 revising Government Code Section 7072, requiring Enterprise Zones
16 to designate eligible census tracts by the United States Department of Housing and Urban
17 Development as having at least 51 percent of its residents of low or moderate income levels,
18 using either the most recent United States Department of Census data available at the time of
19 the original enterprise zone application or the most recent census data available at the time
20 the targeted employment area is designated to determine that eligibility; and

21 WHEREAS, On May 27, 2007 the City and County of San Francisco Enterprise Zone
22 designation ended, and was replaced by the State Department of Housing and Community
23 Development as of May 28, 2007, with a new conditionally approved 15-year zone
24 designation pursuant to the Enterprise Zone Act; and

1 WHEREAS, On March 19, 2007, the State Department of Housing and Community
2 Development authorized that existing Targeted Employment Areas shall remain in effect for
3 conditionally approved Enterprise Zones until they receive final designation. With final
4 designation status, the new Enterprise Zones will need to formally apply for new Targeted
5 Employment Area; now, therefore, be it

6 RESOLVED, By the City and County of San Francisco Board of Directors as follows;
7 Section 1. Resolution No.1036-98 is hereby authorized to remain in effect as the qualified
8 Targeted Employment Area for the 1992 Enterprise Zone designation and through the
9 conditional approval phase of the Enterprise Zone application process. Upon final designation
10 from the State Department of Housing and Community Development, the census tracts will
11 expire; and, be it

12 FURTHER RESOLVED, That the following census tracts have been designated by the
13 United States Department of Housing and Urban Development as having 51 percent of its
14 residents at low or moderate income levels, and hereby identified as those census tracts
15 which are in the most need of employment targeting pursuant to the Enterprise Zone Act, as
16 amended: 101, 106, 107, 110, 111, 113, 114, 115, 117, 118, 119, 120, 121, 122, 123, 124,
17 125, 151, 155, 158, 159, 160, 161, 162, 163, 164, 168, 176.01, 176.02, 177, 178, 201, 202,
18 207, 208, 209, 210, 227.03, 228.02, 228.03, 229.01, 230.01, 230.02, 230.03, 231.01, 231.02,
19 231.03, 232, 234, 606, 607; and, be it

20 FURTHER RESOLVED, That a targeted employment area composed of the above
21 specified census tracts and having the boundaries created by grouping said census tracts
22 together, as shown on Exhibit A, attached hereto and incorporated herein, is hereby
23 approved; and, be it

1 FINALLY RESOLVED, That approved census tracts for the new 2007 Enterprise Zone
2 Final Designation are subject to approval by the Department of Housing and Community
3 Development.

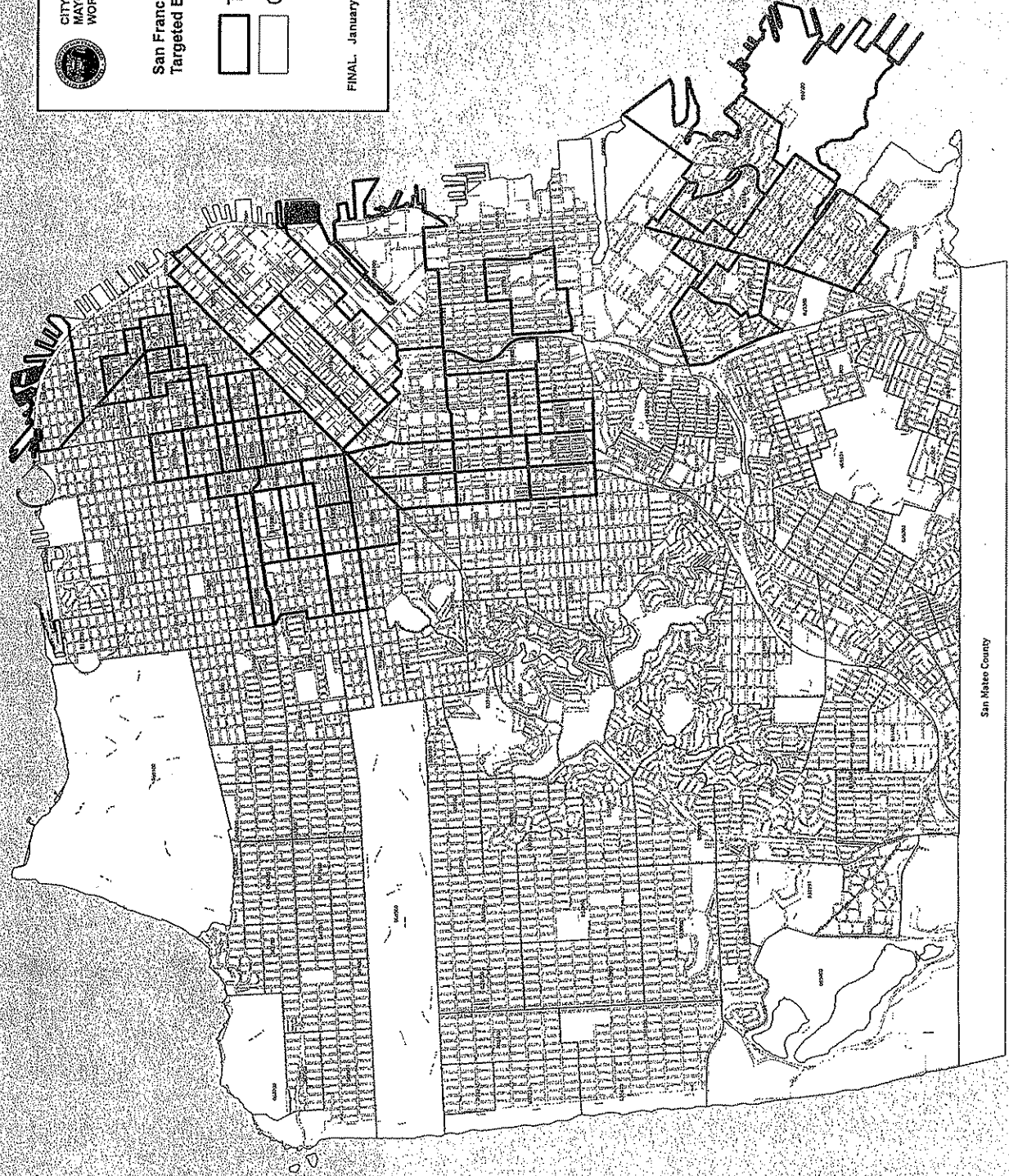


San Francisco Enterprise Zone
