

1 [Contract Agreement - Progress Foundation - Behavioral Health Services - Not to
2 Exceed \$9,645,691]

3 **Resolution retroactively approving an original agreement for residential**
4 **behavioral health services for adults, between the Department of Public Health**
5 **and Progress Foundation, in the not to exceed amount of \$9,645,691 for a total**
6 **contract term of six months, from July 1, 2018, through December 31, 2018.**

8 WHEREAS, The Department of Public Health, in order to provide residential
9 behavioral health services for adults to the residents of San Francisco, conducted a
10 Request for Proposals on October 27, 2017 (RFP 7-2017), which anticipated an initial
11 term of one year, with one option for an additional four years and another option for an
12 additional five years, to a maximum term of ten years; and

13 WHEREAS, The Department of Public Health awarded a contract under this
14 Request for Proposals to the Progress Foundation (the "Contractor"); and

15 WHEREAS, A copy of the proposed original agreement is on file with the Clerk of
16 the Board of Supervisors in File No. 180656, which is hereby declared to be a part of
17 this resolution as if set forth fully herein; and

18 WHEREAS, In order to ensure continuity of services, under San Francisco
19 Administrative Code, Section 21.42, Department of Public Health has established an
20 interim contract agreement with Progress Foundation for a contract term which partially
21 overlaps the term of this contract agreement; and

22 WHEREAS, Until the final FY2018-2019 Department of Public Health budget is
23 approved by the Board of Supervisors, Contractor is unable develop its final FY2018-
24 2019 budget, this contract agreement contains FY2017-2018 budget documents, which
25 will be revised to reflect the Department of Public Health's FY2018-2019 budget as

1 approved by the Board of Supervisors, and which will not exceed the maximum
2 compensation specified in this contract agreement; and

3 WHEREAS, That interim contract shall terminate and be replaced by this
4 agreement, effective the first day of the month following the date upon which the
5 Controller's Office certifies as to the availability of funds for this agreement; and

6 WHEREAS, That interim contract shall be extended only to allow for
7 reconciliation and payment for services provided during the period not replaced by this
8 contract agreement; now, therefore, be it

9 RESOLVED, That the Board of Supervisors hereby authorizes the Director of
10 Public Health and Director of the Office of Contract Administration/Purchaser, on behalf
11 of the City and County of San Francisco, to execute a contract with Progress
12 Foundation, in the amount of \$9,645,691 for a total term of July 1, 2018, through
13 December 31, 2018; and, be it

14 FURTHER RESOLVED, That the Board of Supervisors authorizes the
15 Department of Public Health to enter into any amendments or modifications to the
16 contract, prior to its final execution by all parties, that the Department determines, in
17 consultation with the City Attorney, are in the best interest of the City, do not otherwise
18 materially increase the obligations or liabilities of the City, are necessary or advisable to
19 effectuate the purposes of the contract, and are in compliance with all applicable laws;
20 and, be it

21 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
22 by all parties, the Director of Health and/or the Director of the Office of Contract
23 Administration/Purchaser shall provide the final contracts to the Clerk of the Board for
24 inclusion into the official file (File No. 180656).
