

Accept-Expend a Non-Profit Organization Grant

1 AUTHORIZING THE JUVENILE PROBATION DEPARTMENT TO ACCEPT AND EXPEND A  
2 GRANT IN THE AMOUNT OF \$12,500 FROM THE VOLUNTEER AUXILIARY OF THE  
3 YOUTH GUIDANCE CENTER TO FUND, IN PART, A LIBRARY PROGRAM IN JUVENILE  
4 PROBATION DEPARTMENT'S JUVENILE HALL DETENTION CENTER AND LOG CABIN  
5 RANCH RESIDENTIAL FACILITY.

7 WHEREAS, it is in the best interests of the City and County of  
8 San Francisco to encourage it's children to read and appreciate  
9 literature; and

10 WHEREAS, (the Juvenile Probation Department and the Unified  
11 School District do not currently provide a library program for youth  
12 detained at Juvenile Hall or Log Cabin Ranch; and;

13 WHEREAS, the Volunteer Auxiliary of Youth Guidance Center is  
14 graciously offering a donation of \$12,500 to the Juvenile Probation  
15 Department to fund, in part, a first year library program in Juvenile  
16 Hall and Log Cabin Ranch; and

17 WHEREAS, the San Francisco Public Library is offering to match  
18 the Auxiliary gift with \$9,750 and the Juvenile Probation Department  
19 is offering to match the gift with \$25,000, to fund the total program  
20 cost of \$47,250: and

21 WHEREAS the San Francisco Public Library will have to create one  
22 additional limited-tenure Librarian 1, at a total cost of \$47,250 for  
23 salary and fringe benefits, to administer this new library program;



7 library program in Juvenile Hall and Log Cabin Ranch; and be it


8 FURTHER RESOLVED, That the San Francisco Public Library be




