7 were slowly diminishing; and,

8 WHEREAS, Mr. Monroe and Mr. Ernest produced the North Beach Jazz  
9 Festival to bring about the revival of jazz culture to San  
10 Franciscans of all ages; and,

11 WHEREAS, Jazz has been a great influence in American culture and  
12 the North Beach Jazz Festival is a celebration of that history and an  
13 event to continue the tradition of jazz in North Beach; and,

14 WHEREAS, the First Annual North Beach Jazz Festival was planned  
15 for April 1995, and was rained out and postponed; and,

16 WHEREAS, over the years, the North Beach Jazz Festival has grown  
17 from a one-day concert drawing approximately 800 people into a 9-day  
18 event filled with multiple artists and numerous locations; and,

19 WHEREAS, the North Beach Jazz Festival is now in its sixth year  
20 of bringing together thousands of music enthusiasts; therefore, be it

21 RESOLVED, That the Board of Supervisors hereby commends the  
22 North Beach Jazz Festival for its exhibition and preservation of San  
23 Francisco's jazz history and culture; and, be it


