5 AUTHORITY WHEN A DOG HAS BEEN VACCINATED FOR RABIES.



7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. Article 1 of the San Francisco Health Code is hereby amended by amending  
9 Section 41.25, to read as follows:

10 **SEC. 41.25. PENALTIES.** (a) Any person violating the provisions of Section 41.21 of  
11 this Article shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be  
12 punishable by a fine of not more than \$500.

13 (b) Any person violating the provisions of Section 41.15, 41.18(c) or 41.19 of this  
14 Article shall be deemed guilty of an infraction and upon conviction thereof shall be punishable  
15 by a fine of not less than \$25 nor more than \$50.




