3 **Motion appointing Tommy Escarcega, Mary Campbell, Gerald Miller and ShaMauda**
4 **Bishop, terms to be determined, to the Reentry Council, residency requirement waived.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated persons to serve as members of the Reentry
8 Council, pursuant to the provisions in the San Francisco Administrative Code Sections 5.1-1
9 through 5.1-6, for the terms specified:

10 Tommy Escarcega (residency requirement waived), seat 1, new appointment, must be
11 a former inmate in the San Francisco County Jail, a California Department of Corrections and
12 Rehabilitation facility and/or a United States Bureau of Prison facility, for a two-year term to be
13 determined.

14 Mary Campbell, seat 2, new appointment, must be a former inmate in the San
15 Francisco County Jail, a California Department of Corrections and Rehabilitation facility and/or
16 a United States Bureau of Prison facility, for a two-year term to be determined.

17 Gerald Miller, seat 3, new appointment, must be a former inmate in the San Francisco
18 County Jail, a California Department of Corrections and Rehabilitation facility and/or a United
19 States Bureau of Prison facility, for a two-year term to be determined.

20 ShaMauda Bishop, seat 4, new appointment, must be a former inmate in the San
21 Francisco County Jail, a California Department of Corrections and Rehabilitation facility and/or
22 a United States Bureau of Prison facility, for a two-year term to be determined; and, be it

23 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 24 1. The membership of the Reentry Council has a goal to be representative of the
25 diversity of the City and County of San Francisco.

2. Applicant Tommy Escarcega, an appointee, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him to serve on the Reentry Council.

3. The Reentry Council has attempted to fill the position, for which Tommy Escarcega was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Tommy Escarcega is qualified to serve on the Reentry Council.

4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Reentry Council at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Tommy Escarcega, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
