9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. The San Francisco Police Code is hereby amended by adding Section  
11 1075.1, to read as follows:

12 **SEC. 1075.1. TRANSFER OF REGULATORY AUTHORITY TO MUNICIPAL**  
13 **TRANSPORTATION AGENCY.**

14 Pursuant to the authority granted in Charter Section 8A.101, the Board of Supervisors hereby  
15 abolishes the Taxi Commission and transfers the functions, powers and duties of the Taxi Commission  
16 to the Municipal Transportation Agency.

18 Section 2. This ordinance shall be operative on March 1, 2009, provided that such  
19 operative date shall not affect the authority of the Controller, the Director of Human  
20 Resources, the Clerk of the Board of Supervisors or the City Attorney granted under Section 6  
21 of the Annual Appropriations Ordinance related to transfers of functions and duties.
