3 **Resolution extending by 30 days the prescribed time within which the Planning**
4 **Commission may render its decision on a proposed Ordinance amending Sections**
5 **102.17, 790.38, and 890.37 of the San Francisco Planning Code to define three types of**
6 **entertainment use based upon size; amending Sections 1060, 1060.1, 1060.3, 1070,**
7 **1070.1, and 1070.3 of the San Francisco Police Code to define the three types of**
8 **entertainment use authorized by the Planning Code and to require an application and**
9 **the permit for a place of entertainment or extended-hours activity to specify one of the**
10 **three types of entertainment use; adopting findings, including environmental findings**
11 **and findings required by Section 302 of the Planning Code.**

13 WHEREAS, On December 4, 2007, Supervisor Peskin introduced an Ordinance
14 initiating the amendment of Planning Code Sections 102.17, 790.38, and 890.37 to define
15 three types of entertainment use based upon size; amending Sections 1060, 1060.1, 1060.3,
16 1070, 1070.1, and 1070.3 of the San Francisco Police Code to define the three types of
17 entertainment use authorized by the Planning Code and to require an application and the
18 permit for a place of entertainment or extended-hours activity to specify one of the three types
19 of entertainment use. A copy of said legislation is on file with the Clerk of the Board of
20 Supervisors in File No. 071649 and is incorporated herein by reference; and,

21 WHEREAS, On or about December 12, 2007, the Clerk of the Board of Supervisors
22 referred the proposed ordinance to the Planning Commission, which currently is reviewing the
23 proposed ordinance; and,

24 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by
25 resolution, extend the prescribed time within which the Planning Commission is to render its

1 decision on proposed amendments to the Planning Code that the Board of Supervisors
2 initiates; and,

3 WHEREAS, The Planning Department has requested additional time to review the
4 proposed ordinance; and,

5 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning
6 Commission additional time to review the proposed ordinance and render its decision; now
7 therefore be it

8 RESOLVED, That by this resolution, the Board hereby extends the prescribed time
9 within which the Planning Commission may render its decision on the proposed ordinance for
10 an additional 30 days, or until April 11, 2008.


