Section 1. The Board of Supervisors hereby adopts and implements the decision and award of the Arbitration Board under Charter Section A8.409-4, establishing the Memorandum of Understanding ("MOU") between the City and County of San Francisco and San Francisco City Workers United (Painters), to be effective July 1, 2024 through June 30, 2027.

Section 2. The Board of Supervisors hereby authorizes the Department of Human Resources to make non-substantive ministerial or administrative corrections to the MOU.

Section 3. This ordinance shall become effective upon enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not

sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
