11 alcoholic beverage control license and Type 42 on-sale beer and wine public premises
12 license for K & L Wine Merchants located at 638 Fourth Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
20 off-sale general alcoholic beverage control license and Type 42 on-sale beer and wine
21 public premises license from 766 Harrison Street to 638 Fourth Street for Todd F.
22 Zucker for K & L Wine Merchants, will serve the public convenience and necessity of
23 the people of the City and County of San Francisco.

24 Conditions: (1) Sales, service or consumption of alcoholic beverages shall be
25 permitted only between the hours of 9:00 a.m. and 7:00 p.m. each day of the week; (2)

1 No malt beverages products shall be sold in less than six-pack quantities per sale; (3)
2 Sales of fortified wines in any size bottle that sell at retail for less than \$5.00 per bottle is
3 prohibited.


