This cease and desist from a San Francisco taxpayer is to hereby demand that you **cease and desist**:

Respectfully addressing  
Members of the BOS Budget Committee,

I'm not sure how many San Franciscans are able to draw this scenario from a firsthand experience: In 1957, I watched from my grandparent's front window at 1745 Ellis Street bulldozers bravely crash and tear down the buildings between Ellis -Steiner- Geary and Pierce Street to make way for the creation of Raymond Kimball Field. Two square blocks stricken from the neighborhood. Done to replace the portion of Hamilton Plaza's baseball diamond which was needed for the strip of land that would become a new 6 lane Geary Boulevard. Once the buildings were demolished, I watched the mostly black men in overalls dig around the strewn debris to collect the desecrated bricks - chip the mortar off and stack them neatly into columns. Told the men would collect a penny a brick for their useful work. That process went on day by day into the evening for quite some time in front of my eyes. The A-1 project for Redevelopment was genuinely on the move forward. By 1958, my family moved around the corner to 1775 O'Farrell, between Steiner and Fillmore, where in the spring there was an announcement of the coming A-2 project. Golly. What is that?

I didn't know why my grandmother was so distraught, but I later found out she was despondent over the news her church, El Bethel, would need to move off Golden Gate Street to a new location, perhaps out in Potrero Hill. Miles from where we lived in Fillmore. She loved that church so much. But she loved living in the Fillmore even more. At that moment, don't believe we knew all the houses would be torn down around us. But sure enough, over the following few years, they were. I was just 6 years old as this all began to unfold. But the images are with me even today just as clear as if it were yesterday. Can't say I'll ever shake the memory of the dust up, smell of the ruins and sound of jack hammers pounding; buildings tumbling and bull dozers squealing and slamming and ratcheting and grinding their motors while the incessant cracking and breaking of wood slats under the trouncing bulldozer tracks became routine. Big trucks hauled away the wreckage of homes where friends and people I knew had once lived. Left with twisted metal and ghostly memories of places that had been meaningful and stable. Memorable if for no other reason than to recall the cool shadows cast off the buildings that danced with the lively sunlight beaming over the sidewalks where we had joyfully skipped rope, shot marbles and ran foot races in our own little concrete world. I remember, I had watched in fear from the O'Farrell Street sidewalk as the St Mary's Cathedral atop the hill in the distance burn to the ground. I wore my little red plastic fireman's helmet as the firetrucks roared up to their destination at Geary and Gough. I

must have been 8 or 9. From 1775 O'Farrell I had one of the many perfect vantage points to see the fire unfold in its totality. As it were, with what was ahead with Redevelopment, the entire neighborhood may as well have burned down with the Cathedral. At least the Cathedral was rebuilt back anew. Bigger, brighter, and better. Our developing culture and budding community were simply left in the ashes and dust. Reduced to 2<sup>nd</sup> class status by orchestrated prejudices. That shouldn't happen again. A Reparations Commission is needed to ensure that it doesn't.

Someone needs to ensure that any Reparation arrangement is done in good faith and with integrity. It is very easy, as I have seen during my 60 years in San Francisco, for good intentions to be undermined by other citizens of good intentions. This, while those designated citizens whose real needs and interest are at stake and maligned. The African American community cannot afford to be left in the dust and forgotten, again. This is why there is an absolute need for a Reparation Commission. An ongoing focus must live with this Reparation process. As the depth of need for reparations continue to evolve.

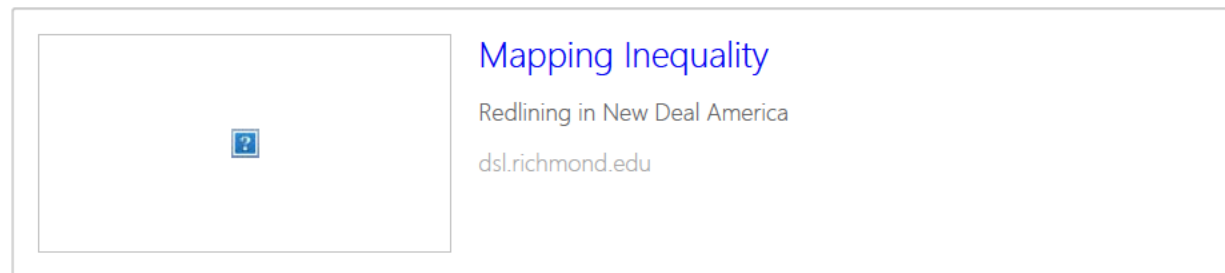
Imagine how well off the entire City could have been, if the Black men and women of the Fillmore who fought to help win WWII and those who helped build record numbers of Victory and Liberty ships around the Bay to supply the War effort had been treated properly after the War. Many more Black citizens could have used their GI Bills and their payroll savings to buy into the new housing stock in the areas of Richmond, Sunset, Merced, Cow Hollow, Presideo. Or, perhaps Marin, San Mateo or Contra Costa County. Today, it is clear, those areas were reserved only for white citizens. 'Redlining' obviously cheated black citizens out of their opportunity for an honest and fair American Dream for which they had just as rightfully earned as white citizens had. Most citizens would have been lifted into a status enabling better chances at greater education, better employment and home equity leading to a more generous set of inheritances and passing on of wealth, resources and options to the generations that followed. A lot has been written about that so-called "greatest generation." But it turns out many of the White citizens in that wartime, who made up that generation weren't so great. They allowed the darker shade of their fellow citizens' skin to blind them of their own biases. There was no oversight group to ensure that didn't happen. For that reason, they should pay into Reparations for colluding against and crippling the Black community during the past, at least 85 years here in San Francisco. (I wonder if bigotry in the segregated military had anything to do with why only 44% of Black military men received 'Honorable Discharges' after WWII while a robust 78% of White military men did receive the Honor?}

There is just no two ways to see this. One set of citizens intentionally orchestrated unfair legislation, 'Redline Acts' and evil housing covenants against another set of equally decent American citizens - a disenfranchisement because of the shade of their skin. This, to the

detriment of those in the darker group, There should have been an honest watchdog body to oversee this through the decades. Shifting sands must be held accountable. As it were, back then, the lighter skin citizens were given privileges at the expense of the darker skin citizens. Resulting in an unbalanced, unfair capacity for generational wealth through the decades. There is ample evidence that reflects this inequality, easily.

For instance: This interactive map demonstrates the challenge posed by those determine to keep African Americans at a disadvantage when it came to fair and equitable opportunities in San

Thereby, people like me, a Black Man whose family members contributed much to the building of the San Francisco success story; through our military services, health care work, tourism ambassadorship and educator efforts, during, at least 75 years. Yet no one knows that. A Reparations Commission can be positioned to acknowledge and validate why Reparations benefit all Citizens of San Francisco as the years move forward. That's important to note. But first, we tenured Black Citizens should be made whole. And, 'whole' should be reflected in and based on what European Americans, who were advantaged by GI Bill benefits and not weighted down by Redlining and housing 'covenants,' trade unions and Guild prejudices but were able to gain in wealth equity and leverage during the last 170 years. Or, more precisely - what we missed during the last 80 years we Black were kept out of Trade Unions and Guilds; Intentionally relegated to menial task employment; Pushed into highly toxic communities to live; While an army of intense, misguided men and women acting as law enforcement agents routinely came into our neighborhoods with no regard for our health, safety or wellbeing to pick our pockets. Then, there were the European American civilian mortgage lenders/ appraisers and finance people who cheated our military men out of their GI Bill loans for housing and education. All of this should be accounted for by a Reparation Commission.

Not only should all 111 reparation items and cash benefit be forth coming, but an ongoing watch dog group of Reparation Commissioners must be appointed to be sure it's done properly. To fail that ongoing oversight duty would leave these assurances open to future

misleading interpretations which could skirt the moral principles or standards of decency in human behavior ordinarily protected by international law. And certainly, interpretations by this body of the Board of Supervisors would want to protect. Otherwise, our African American community would be right back where it started. That's useful to no one. Sometimes people don't remember the facts or like to conveniently forget them.

I trust this Budget Committee will advocate and settle on the right process and action to bring this progressive consideration before the full BOS.

**I do not apologize** for the length of this email. I am a 70-year-old Black woman who has a long and loving relationship with the City of Saint Francis. I hope out of respect for that relationship that, you will read this entire email.

My mother and I came to San Francisco in 1956, leaving Atlanta, Georgia. The impetus for the move was to give me her only child a better life, which was the desire of every Black parent that was part of the Black migration from the South.

My mother had a friend that was in San Francisco because of the employment that was available for longshoremen. Not the wages that **white unionized longshoremen** (Black men were not allowed to join the union) made, but it was a better salary than the South offered to Black men.

I was educated in San Francisco public schools. I was an excellent student, never suspended. I attended Raphael Weill Elementary. In Everett Middle School, I was given a certificate for never missing a day of school. I then attended Polytechnic (Poly) High School.

I had the opportunity to attend Lowell because of my grades, but the known prejudice and racism at the school caused me to select Poly, where I felt safer. I am glad I made that choice because I excelled at Poly in academics. I was on the College Prep Track, where there were few Black students. I was the only Black student in a Calculus class and in most of my science classes.

I was granted the opportunity to participate in the Upward Bound Program at the University of San Francisco (USF) for two summers. Because of that opportunity, I was given a four-year scholarship to USF through their affirmative action program.

During my entire education in San Francisco schools, I **never** had a Black teacher.

The **deficiencies of my public school education** became evident during my first semester at USF. My A's were probably comparable to the C's of these Catholic, Private school-educated students I was competing with. I was playing catch-up, on day one at USF.

I struggled at USF; I was the first on my mother's side to attend college. I didn't know

who to ask for help, and I didn't want to disappoint my mother, knowing the sacrifices she had made for me.

That struggle continued into my Law School Studies. I went to San Francisco Law School in the evening. The struggle in College and Law School was because of true grit, and determination that got me through each experience. How much easier that would have been if I had been given the quality education that I deserved.

I grew up in the Western Addition, if you haven't figured it out yet. In the Western Addition, Black people had all they needed regarding stores, retail, and grocery. There was entertainment, jazz clubs, bars, and theaters for children to go to on Saturdays. Booker T. Washington Community Center was also a safe place for me to go after school and during the summer for day camp. It later became a place where my mother enjoyed Senior activities.

A dime would keep me at the Hamilton Recreation Center, where I learned to swim and play tennis and would spend my Saturdays.

I worked in the District Attorney's Office for 34 years, 9 months, and 22 days. Twelve years (12) as an investigator and twenty-two years (22) as an Assistant District Attorney under five administrations.

After retiring from the District Attorney's office, I went to Seminary and was Ordained a United Methodist Church (UMC) pastor as a Deacon. Deacon in the UMC is the minister that's a bridge between the world and the church. I was appointed to Glide UMC initially, and then I was appointed as a pastor that was responsible for the social justice work for the eight remaining UM Churches in San Francisco.

The only Black UMC is Jones UMC in the Western Addition, which was my home church. The decline of Black UM Churches is a direct result of Black flight due to housing expenses and under-employment.

The Black church was where the Black leaders of the city were groomed. In my home church alone, we had a judge, lawyers, doctors, and many who served on City agencies and Boards. We even had a Credit Union, because Blacks couldn't get credit cards from stores and financing for purchasing cars. I purchased my first car, a 1967 Mustang, with financing from the Jones Methodist Credit Union.

I am also a member of the San Francisco Alumnae Chapter, of Delta Sigma Theta, Inc., which has been an active participant in the Black community of San Francisco for 75 years.

You can see my love for San Francisco runs deep and continuous. But when I needed and wanted to purchase a place to live, I couldn't afford to do so. As a single woman, I had additional concerns about my physical safety in selecting a neighborhood to live in, a concern that all women have, and therefore, we pay more for rent. With that

concern, the cost became more than I could afford, so I purchased a condo in the east bay.

I have remained faithful to San Francisco even after leaving forty-one (41) years ago. It is where I still worship, shop, dine out, seek entertainment, support my community, etc.

I have watched with great interest the work of the African American Reparations Advisory Committee. Their work has been stellar, thought-provoking, and “on point” in documenting with subject-matter experts the prejudice, injustices, redlining, and economic devastation that the Black citizens of San Francisco have suffered over the decades.

I **am not** looking for any monetary payment for myself. The direct harm I suffered was the lack of quality education, the financial harm from that injustice cannot be calculated, but it can be corrected for the generations following.

I am asking you to vote **YES** on funding initiatives and programs that will begin to right some of the wrongs that have been done to the Black citizens of San Francisco. That will give future generations equality in education, job opportunities, and housing purchase and rental.

All the Supervisors voted for the Taskforce to research the issue; that research now comes with a price tag.

**Did you not think there would not be a price to pay for decades of racism, sexism, redlining, and redevelopment lies?**

Dear Honorable Board of Supervisors,

As a long-time resident and taxpayer of the City and County of San Francisco, I am writing to demand that you immediately **cease** all publicly-funded work on consideration of *The Draft San Francisco Reparations Plan* (the “*Plan*”), and **desist** from any future use of taxpayer monies in expenditures for or relating to the *Plan*. Moreover, I specifically demand that you **cease and desist** from approving and implementing an appropriation of \$50 million of taxpayer funds for creating an “Office of Reparations” as requested March 21, 2023 by Supervisor Shamann Walton, joined by Supervisor Dean Preston and Supervisor Hillary Ronen.

While various aspects of the *Plan* violate numerous different constitutional provisions as well as pre-emptive state and federal statutes,<sup>1</sup> the *Plan* clearly violates the Equal Protection Clause of the Fourteenth Amendment of the United States Constitution and Article I, Section 7 of the California Constitution.<sup>2</sup> Both constitutional provisions strictly prohibit race discrimination under nearly all circumstances.<sup>3</sup> The *Plan* makes clear that **only** African American residents and African American former residents of San Francisco will be considered eligible for reparations programs, clearly discriminating on the basis of race in violation of both the federal and state equal protection clauses.<sup>4</sup>

While there may be some very narrowly limited exceptions in the United States Constitution that allow for the government to discriminate on the basis of race,<sup>5</sup> the California Constitution strictly prohibits even those narrow and limited exceptions.<sup>6</sup> And while some may argue that racial discrimination is permissible because it is “slavery reparations”, the United States Supreme Court recently made clear in *Bostock v. Clayton County*,<sup>7</sup> “it’s irrelevant what [one] might call its discriminatory practice, how others might label it, or what else might motivate it.”<sup>8</sup> Moreover, while some may attempt to argue the *Plan* is legal because it will exclude some African Americans from reparations who fail to meet other requirements, the United States Supreme Court in *Bostock* also reaffirmed that prohibited discrimination is still illegal even if there are other motivating factors involved in the discriminatory action.<sup>9</sup>

The San Francisco Board of Supervisors is not only considering implementation of the *Plan*, despite its clear unconstitutionality, but also apparently considering an advance appropriation of \$50 million to establish an office to determine eligibility for recipients under the *Plan*. This is a violation of your oath and duty as elected officials to uphold and defend the United States and California Constitutions.<sup>10</sup>

Fortunately, there is a remedy. California Civil Procedure Code § 526a allows any taxpayer in the City and County of San Francisco to bring a taxpayer lawsuit or citizen lawsuit against the City and County of San Francisco for the violation of the United States and California Constitutions should the *Plan* be enacted.<sup>11</sup> More importantly, California Civil Procedure Code § 526a also allows taxpayers to bring an action for the waste of public funds.<sup>12</sup>

The action for a waste of public funds is its own independent cause of action against government, separate from the violations of the constitution.<sup>13</sup> A waste of public funds is described as a government expenditure that, even when lawfully done, is “completely unnecessary,” “useless,” or “provides no public benefit.”<sup>14</sup> A waste of public funds undoubtedly occurs when the government spends money to administer an illegal or unconstitutional program.<sup>15</sup>

Indeed, the California Supreme Court has prohibited expenditures by city and county governments for the waste of public funds when the funds would have been expended for a violation of the Constitution.<sup>16</sup> As the California Court of Appeals has explained, “a court must not close its eyes to wasteful, improvident and completely unnecessary public spending, merely because it is done in the exercise of a lawful power.”<sup>17</sup>

The appropriation of \$50 million of taxpayer money by the City and County of San Francisco to establish an office of reparations for a program that is unconstitutional and will be unable to legally meet its objectives, is clearly a waste of public funds. Thus, I demand that the Board of Supervisors **cease and desist** from implementing any allocation of public funds for determining recipient eligibility under the *Plan*.

I further demand a full accounting of all monies allocated, received and spent, salaries paid, beginning January 1, 2020 through April 17, 2023 inclusive, by the African American Reparations Advisory Committee and the San Francisco Human Rights Commission, on the creation and drafting of the *Plan*.

You are hereby demanded to respond to this Cease & Desist Letter within ten (10) business days from receipt, via email to richie@greenbergnation.com or via messenger to the address above, informing me of whether you will comply. Should you fail to cease implementation of expenditures for determining eligibility under the *Plan*, I will consider taking legal action. Thank you for your cooperation in this matter.

Dear Budget and Finance Committee,

There is no question whether Black people in the USA, in San Francisco, deserve reparations. Of course they do. The enormous magnitude of this task is going to take a lot of work and so it's logical to create and fund an Office of Reparations dedicated to this sole task. Frankly if you're not Black I don't believe you should get a vote on this, but that's not the case. So I leave you with an account from a formerly enslaved person. How much work is it going to take to calculate and distribute reparations for this? Why wouldn't you have dedicated staff to repair the generational torture and trauma from slavery? Not to mention the continued onslaught of anti-Black racism in this country.

Millie Ann Smith was born in 1850, in Rusk Co., Texas, enslaved by George Washington Trammell, a planter of the county. Interview between 1936-1938.

"I's born 'fore war started and 'members when it ceased. I guess mammy's folks allus belonged to the Trammells, 'cause I 'member my grandpa, Josh Chiles, and my grandma, call Jeanette. I's a strappin' big girl when they dies. Grandpa used to say he come to Texas with Massa George Trammell's father when Rusk County was jus' a big woods, and the first 2 years he was hunter for the massa. He stay in the woods all the time, killing deer and wild hawks and turkeys and coons and the like for the white folks to eat, and the land's full of Indians. He kinda taken up with them and had holes in the nose and ears. They was put there by the Indians for rings what they wore. Grandpa could talk mos' any Indian talk and he say he used to run off from his massa and stay with the Indians for weeks.

The massa'd go to the Indian camp looking for grandpa and the Indians

hided him out and say, 'No see him.' How mammy and we'uns come to Texas, Massa George brung his wife and 3 chillen from Mississippi and he brung we'uns. Pappy belonged to Massa Moore over in Mississippi and Massa George didn't buy him, but after mammy got here, that 'fore I's born, pappy runs off and makes his way to Texas and gits Massa George to buy him.

The overseer come 'round at 9 o'clock to see if all is in the bed and then go back to his own house. When us knowed he's sound asleep we'd slip out and run 'round, sometimes. They locked the young men up in a house at night and on Sunday to keep 'em from runnin' 'round. It was a log house and had cracks in it and once a little [Black] boy pokes his hand in tryin' to tease them men and one of 'em chops his fingers off with the ax. Massa didn' 'low no Black person] to read and write, if he knowed it.

George Wood was the only one could read and write and how he larn, a little boy on the 'jining place took up with him and they goes off in the woods and he shows George how to read and write. Massa never did find out 'bout that till after freedom. We slips off and have prayer but daren't 'low the white folks know it and sometime we hums 'ligious songs low like when we's workin'. It was our way of prayin' to be free,

Massa George and Missy America lived in a fine, big house and they owned more slaves and land than anybody in the county and they's the richest folks 'round there. Us slaves lived down the hill from the big house in a double row of log cabins and us had good beds, like our white folks. My grandpa made all the beds for the white folks and us [Black folks], too. Massa didn't want anything shoddy 'round him, he say, not even his [enslaved] quarters.

I's sot all day handin' thread to my mammy to put in the loom, 'cause they give us homespun clothes, and you'd better keep 'em if you didn't want to go naked. Massa had a overseer and [Black man] driver call Jacob Green. If a [Black person] was hard to make do the right thing, they ties him to a tree, but Massa George never whip 'em too hard, jus' 'nough to make 'em 'have. The slaves what worked in the fields was woke up 'fore light with a horn and worked till dark, and then there was the stock to tend to and cloth to weave.

The overseer come 'round at 9 o'clock to see if all is in the bed and then go

back to his own house. When us knowed he's sound asleep we'd slip out and run 'round, sometimes. They locked the young men up in a house at night and on Sunday to keep 'em from runnin' 'round.
