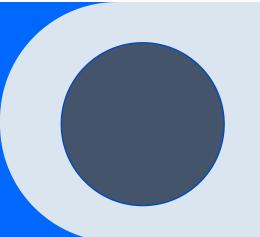

Provide final approval authority for professional/personal service contracts over \$200K expeditiously while maintaining transparency with the unions and the public

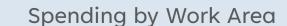

#### CSC Budget Allocation by work area





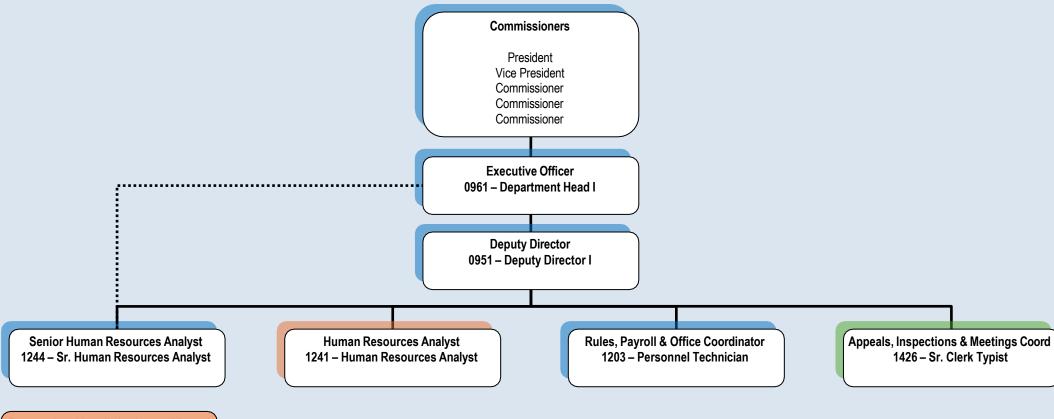

#### Mayor's proposed budget for CSC

The proposed Fiscal Year (FY) 2025-26 budget of \$1.39 million for the Civil Service Commission is \$0.19 million, or 13 percent, lower than last year's proposed FY 2025-26 budget. This is due to Mayor's budget instruction to reduce the department's budget by 15%.

The FY 2026-27 proposed budget of \$1.44 million is \$0.14 million, or 9.6 percent, lower than the projected increases primarily due to the position reduction required in the FY 2025-26 proposed budget.
