2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 48 ON-SALE  
3 GENERAL PUBLIC PREMISES ALCOHOLIC BEVERAGE CONTROL LICENSE TO  
4 RAYMOND J. PITTMAN FOR TOMA HOLDINGS, LLC, DBA "TOMA" FROM 511  
5 HARRISON STREET TO 85 NATOMA STREET, (DISTRICT 6) WILL SERVE THE  
6 PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE CITY AND  
7 COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF THE  
8 CALIFORNIA BUSINESS AND PROFESSIONS CODE; WITH CONDITIONS.

10 WHEREAS, Raymond J. Pittman is seeking transfer of a Type 48 on-sale  
11 general public premises alcoholic beverage control license for Toma located at 85  
12 Natoma Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48  
20 on-sale general public premises alcoholic beverage control license to Raymond J.  
21 Pittman for Toma Holdings, LLC, dba "Toma" from 511 Harrison Street to 85 Natoma  
22 Street, (District 6) will serve the public convenience and necessity of the people of the  
23 City and County of San Francisco.

24 Conditions: 1) Sales, service, or consumption of alcoholic beverages shall be  
25 permitted only between the hours of 5:00 p.m. and Midnight, Sunday through Thursday

1 and between the hours of 5:00 p.m. and 2:00 a.m., Friday and Saturday. 2) There shall  
2 be no live entertainment of any type, including live music, deejay, or karaoke. 3) There  
3 shall be no dancing permitted on the premises at any time. 4) A single jukebox or  
4 stereo may be maintained upon the premises; however, the music shall not be audible  
5 beyond the premises.


