Resolution authorizing the Department of Elections to accept and expend additional grants under the federal Help America Vote Act of 2002 ("HAVA"), Section 301 in an amount not to exceed \$5,742,340 for voting equipment to be used for the November 2007 election and elections the ceafter.

[Accept-Expend Federal and State Grants for Voting Equipment.]

WHEREAS, The United States Congress has appropriated funding to each state under the Help America Vote Act 0f 2002 ("HAVA"), Section 301, to modernize voting equipment and to improve other aspects of the elections process; and

WHEREAS, The California Secretary of State received HAVA funds and is allocating a portion of this funding to each county to modernize voting equipment; and

WHEREAS. The Department of Elections is eligible to receive grants to assist in implementing HAVA to modernize the City and County's voting equipment; and,

WHEREAS, The Department of Elections applied for and has been allocated Proposition 41 funds; and,

WHEREAS. The California Secretary of State has been delegated the responsibility for the administration of HAVA and Proposition 41 funds, setting up the necessary procedures for allocation of those funds; and,

WHEREAS, said procedures established by the California Secretary of State require the City and County to certify, by resolution, the approval of applications for funding before submission of said applications to the California Secretary of State; and,

WHEREAS, the California Secretary of State currently requires the City and County to expend all HAVA funds allocated to the City and County by no later than June 30, 2007, and

the California Secretary of State has not determined whether this deadline can be extended for expending said funds if the City and County fail to expend the funds; and,

WHEREAS, on August 15, 2006, the Board of Supervisors of the City and County of San Francisco ("Board") passed Resolution No. 497-06 approving the filing and execution of applications and contracts for financial assistance for the purpose of fulfilling duties and responsibilities to be funded from the funds provided under HAVA; and,

WHEREAS, the Department of Elections requires funding for complying with HAVA and for purchasing a new voting system for use in future elections; now, therefore, be it

RESOLVED, That the Department of Elections is hereby authorized to accept and expend grants under HAVA in an amount not to exceed \$5,742,340 from the California Secretary of State for voting equipment to be used in the November 2007 election and future elections; and, be it

FURTHER RESOLVED, That the Director of Elections is authorized to enter into an agreement with the California Secretary of State on behalf of the City and County of San Francisco for the acceptance and expenditure of these HAVA funds.
