

1 [Settlement of Unlitigated Claim - International Federation of Professional and Technical
2 Engineers, Local 21 - \$201,174 - Suspending Rule 3.25.2]

3 **Resolution suspending Board Rule 3.25.2 requiring referral of this settlement to the**
4 **Government Audit and Oversight Committee, and approving the settlement of the**
5 **unlitigated claim filed by International Federation of Technical Engineers, Local 21**
6 **against the City and County of San Francisco for \$201,174; the claim was filed with the**
7 **Public Employee Relations Board on May 4, 2026, Case No. SF-CE-2400-M; the claim**
8 **involves an unfair practice charge arising from an employment dispute.**
9

10 WHEREAS, The International Federation of Technical Engineers, Local 21 filed a claim
11 against the City with the Public Employee Relations Board on May 4, 2026, Case No. SF-CE-
12 2400-M; and

13 WHEREAS, The claim alleges an unfair practice charge for violations of the Meyers-
14 Milius Brown Act, involving the City's decision to lay off certain permanent civil service
15 employees and certain exempt employees; and

16 WHEREAS, The Department of Human Resources has recommended settlement of
17 the claim by payment of \$201,174 and;

18 WHEREAS, Board Rule 3.25.2 requires referral of settlements to the Government Audit
19 and Oversight Committee, but this Resolution has been referred to the Budget and Finance
20 Committee so that the Board may approve it before its August recess; and

21 WHEREAS, Board Rule 5.2 allows Board Rule 3.25.2 to be suspended by the
22 affirmative vote of eight Board members, unless there are fewer than eight Board members
23 present, in which case the unanimous consent of the Board members present but not less
24 than six members, shall be required; now, therefore, be it

1 RESOLVED, That Board Rule 3.25.2 requiring referral of this Resolution to the
2 Government Audit and Oversight is suspended, and this Resolution may be heard in the
3 Budget and Finance Committee; and, be it

4 FURTHER RESOLVED, That pursuant to Administrative Code, Section 10.22, the
5 Board of Supervisors hereby authorizes the City Attorney to settle and compromise the claim
6 by payment of \$201,174.
