Ordinance amending part II, Chapter V, of the San Francisco Municipal Code (Health Code) by amending section 128 thereof, to fix Patient Rates for services furnished by Department of Public Health, <sup>retroactive to</sup> ~~effective~~ July 1, 2001.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Part II, Chapter V of the San Francisco Municipal Code (Health Code) is hereby amended by amending Section 128, to read as follows:

Sec. 128 PATIENT RATES. The Board of Supervisors of the City and County of San Francisco does hereby determine and fix the proper reasonable amounts to be charged to persons for services furnished by Department of Public Health as follows, which rates shall be effective for services delivered as of ~~January 1, 2001~~ July 1, 2001.
