3 **Resolution approving criteria and procedures for allocating and expending HOPE SF**
4 **Funds and authorizing expenditure of HOPE SF Funds consistent with the approved**
5 **criteria and procedures.**

7 WHEREAS, As a result of chronic underfunding by the federal government, Mayor
8 Newsom and Supervisor Maxwell selected a broad-based task force in Fall 2006 to provide
9 recommendations for addressing the conditions in San Francisco's most distressed public
10 housing while also enhancing the lives of current residents; and,

11 WHEREAS, The task force made recommendations to the Mayor and the Board of
12 Supervisors in May 2007 in a report called "Hope SF: Rebuilding Public Housing and
13 Restoring Opportunity for its Residents", a copy of which is located in Board File No.
14 071373; and,

15 WHEREAS, On July 24, 2007, the Board of Supervisors adopted Ordinance No. 180-
16 07 (Board File No. 070849) (the "HOPE SF Ordinance") establishing the HOPE SF Fund,
17 directing the appropriation of \$5 million to the HOPE SF Fund for FY 2007-2008, setting City
18 policy regarding future appropriations to the HOPE SF Fund, and identifying permitted uses of
19 moneys in the HOPE SF Fund; and,

20 WHEREAS, The HOPE SF Ordinance provided that the HOPE SF Fund shall be
21 administered by the Mayor's Office of Housing, and that the Director of the Mayor's Office of
22 Housing shall promulgate such rules and regulations as he or she may deem appropriate to
23 carry out the provisions of the HOPE SF Fund; and,

1 WHEREAS, The Director of the Mayor's Office of Housing created criteria and
2 procedures for allocating HOPE SF Funds, a copy of which is located in Board File No.
3 071373 (the "HOPE SF Criteria and Procedures"); now, therefore, be it

4 RESOLVED, That the Board of Supervisors approves and ratifies the HOPE SF
5 Criteria and Procedures; and, be it

6 FURTHER RESOLVED, That the Mayor is hereby authorized to enter into such
7 agreements and take such actions to expend the HOPE SF Funds consistent with the HOPE
8 SF Ordinance, the HOPE SF Criteria and Procedures and applicable law; and, be it

9 FURTHER RESOLVED, That all actions heretofore taken by the officers of the City
10 with respect to the HOPE SF Funds and the HOPE SF Criteria and Procedures are hereby
11 approved, confirmed and ratified.


