3 **Resolution authorizing the Department of Public Library to accept and expend a grant**  
4 **in the amount of \$22,000 from the California State Library for continuing family literacy**  
5 **programming as part of Project Read.**

7 WHEREAS, Project Read is a program of the Public Library that helps adults with low  
8 literacy rates improve their skills; and,

9 WHEREAS, Project Read wishes to continue their intergenerational programming in  
10 Family Literacy, assisting parents and children to learn and improve literacy skills together  
11 which has a positive impact on a child's ability to do well in school; and,

12 WHEREAS, The California State Library and through that agency, Children and  
13 Families State Commission (Prop 10), wishes to fund Family Literacy Programs in Libraries;  
14 and,

15 WHEREAS, To maximize use of available grant funds on program services the Public  
16 Library proposes that indirect funds be waived; now, therefore, be it

17 RESOLVED, That the Public Library be authorized to accept and expend a grant in the  
18 amount of \$22,000 from the California State Library for continuing family literacy programming  
19 as part of Project Read; and be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
21 indirect costs in the grant budget, and be it

22 FURTHER RESOLVED. That the Controller designate the Coordinator and the  
23 Outreach Coordinator positions created under the grant as "G" or grant funded positions.  
24 which will terminate when the grant expires.




