9 WHEREAS, Craig Wathen is seeking issuance of a Type 42 on-sale beer and  
10 wine public premises license for City Beer Store, located at 1168 Folsom Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned; and recommends approval; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
18 on-sale beer and wine public premises license, to Craig Wathen for City Beer Store,  
19 located at 1168 Folsom Street will serve the public convenience and necessity of the  
20 people of the City and County of San Francisco.

21 Conditions: (1) Petitioners shall not permit their patrons or the general public to  
22 litter or congregate on the sidewalks adjacent to the licensed premises; (2) The  
23 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the  
24 premises over which they have control; (3) No noise shall be audible beyond the area  
25 under control of the licensee; (4) There shall be no live entertainment of any type

1 permitted on the premises; (5) Sales and service of alcoholic beverages shall be  
2 permitted only between the hours of 10:00 a.m. to 10:00 p.m. each day of the week; (6)  
3 Individual servings shall not exceed six-ounce pours of beer or four-ounce pours of  
4 wine.
