Resolution accepting and expending a gift in place valued at \$288,355 from the Friends of Recreation and Parks to Recreation and Park Department for Lake Merced.

WHEREAS, the natural and recreational resources of Lake Merced are in decline; and, WHEREAS, California Coastal Conservancy provides grant funding to improve both land and aquatic habitats and access in and around the lake; and,

WHEREAS, Friends of Recreation and Parks submitted an application for grant funds on behalf of the Lake Merced Task Force, was awarded a grant for the studies and improvements to the Lake, and delegated the fiscal responsibility of this grant; and,

- Certifies that the City and County of San Francisco Recreation and Park Department are in accordance with the terms and conditions of the agreement with the Friends of Recreation and Parks;

- 3. Certifies that the Recreation and Park Department has reviewed and understands the terms and conditions in the grant agreement;
- 4. Appoints the General Manager as agent of the Recreation and Park Department conduct all negotiations, execute and submit all documents, including but not limited to agreements, payment requests, progress reports and so on, which may be necessary for completion of the aforementioned project.
- 5. Waives inclusion of indirect costs in the grant budget.
