

10 WHEREAS, 3060 Fillmore Market LLC, is seeking the transfer of a Type-20 off-  
11 sale beer and wine liquor license, to do business as Indie Superette, located at 3060  
12 Fillmore Street (District 2); and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed one protest and zero letters of  
16 support with the Department of Alcoholic Beverage Control under California Business  
17 and Professions Code, Section 24013, and recommends that the Department of  
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the  
20 following: 1) Sales, service, and consumption of alcoholic beverages shall be permitted  
21 only between the hours of 8:00 a.m. and 10:00 p.m. each day of the week; and 2)  
22 Petitioner(s) shall actively monitor the area under their control in an effort to prevent the  
23 loitering of persons on any property adjacent to the licensed premises as depicted on  
24 the most recently certified ABC-253; now, therefore, be it

1           RESOLVED, That in accordance with California Business and Professions Code,  
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3 hereby determines that the transfer of a Type-20 off-sale beer and wine liquor license  
4 to 3060 Fillmore Market LLC, doing business as Indie Superette, located at 3060  
5 Fillmore Street, will serve the public convenience or necessity of the City and County of  
6 San Francisco; and, be it

7           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
8 San Francisco hereby endorses and adopts the recommendations of the Police  
9 Department listed above and recommends that the Department of Alcoholic Beverage  
10 Control issue the license with those conditions.
