REQUEST FOR APPLICATION (RFA) DETERMINATION: # 23-10573, Fentanyl Overdose Prevention Grant

Congratulations! The application submitted by your agency in response to RFA #23-10573, Fentanyl Overdose Prevention Grant, is approved for funding. The California Department of Public Health (CDPH)-Substance and Addiction Prevention Branch (SAPB), intends to award a Grant Agreement to San Francisco Department of Public Health pending the successful finalization of your application to incorporate any needed modifications.

The anticipated total funding amount for your agency is **\$1,281,000** for the thirty-six (36) month Grant Agreement term beginning March 1, 2024, through February 28, 2027. Total funding amount **is contingent upon revenues, appropriation by the Legislature and the Governor, CDPH funding priorities, and/or legal or administrative limitations.**

CDPH-SAPB will contact you within the next few weeks to schedule a mandatory modification meeting to discuss your application and any modifications that may be needed. The modification meeting will also be an opportunity to ask questions regarding the terms, funding, and/or conditions of the grant agreement. For this reason, CDPH/SAPB strongly recommends the Project Director/Coordinator and fiscal representative attend the meeting.


CDPH-SAPB will also contact you within the next several weeks regarding contract documents and all communication will be via the CDPH OPI email: OPI@cdph.ca.gov.

To best prepare for the Grant Agreement to be fully executed by March 1, 2024, CDPH-SAPB must submit a draft of the final Grant Agreement documents to the CDPH CMU as soon as possible. If document submission is delayed, a fully executed Grant Agreement may not be in place by March 1, 2023, delaying the project.

Please note, work may **not** commence until March 1, 2024, unless otherwise communicated by CDPH-SAPB, and CMU. Any work done before the full execution of the Grant Agreement will be deemed voluntary and without State reimbursement.

Thank you for your application and your interest in preventing overdose from fentanyl and other opioids. We look forward to working with you.
